- Digital images (.png, .jpg, .jpeg, or .gif format) must be at least 200 dpi (resolution) and not exceed 10 MB in size;
- Entries may be submitted through our 2025 Oklahoma Mobility Week Photo Contest Entry Form or email (ohook@odot.org);
- Photographer retains all copyright privileges for submitted photographs. Photographer grants
  unlimited, nonexclusive use license to the Mobility Management program for mobility week in
  2025 and future mobility week campaigns. The Mobility Management program reserves the
  right to use the photos in printed materials and by electronic means to promote mobility and
  transportation in Oklahoma and Mobility Management programs. As conditions of this
  permission, the Mobility Management program shall credit photographs with proper
  attribution;
- The Mobility Management program is not responsible for late, lost, damaged, destroyed, or misdirected entries or for miscommunications, misdirected transmissions, or other errors of any kind, whether human or electronic;
