Building Committee	The Building Committee recommends that a consultant assess the flooding on the lower floors, which is on-going despite numerous remediation efforts. Discussion raised whether metal doors designed to abate flooding might be a quick and inexpensive solution.	The recommendation to consider metal doors will be communicated to the Building Committee.
Garden Committee	The Garden Committee coffers are not enough to cover the costs of the needed tree removal, hedge maintenance, and other landscaping projects. Tree removal can vary widely in cost, and it was noted that the non-profit Casey Tree has reasonable pricing and plants native trees.	The recommendation to consider Casey Tree as part of shopping for a good price will be communicated to the Garden Committee.
All Souls Bulletin	Embry stated her appreciation to the vestry for their articles and asked about scheduling another round of articles. It was suggested we expand the articles to All Souls members and group leads outside the vestry.
