Points of interest!

- 1. Christmas gifts, birthday gifts. anniversary gifts, and love gifts given through the church are additional income and must be included in the W-2 as wages.
- 2. Not issuing a W-2 or 1099, or 1099NEC, to, non-employee recipients of \$600 or more of annual compensation. A W-2 must be issued to each employee, including most pastors.
- 3. Tax free distributions from IRA's IRA owners who are least 70.5 years of age can make tax free distributions of up to \$100,000 from a traditional IRA to a tax-exempt church or charity (QCD). Give your tithe with tax free dollars, rather than with after tax dollars.
- 4. Qtly 941's do not equal W-2's. The amount of wages reported each quarter on 941 form must equal the sum of your W-2's as reported on form W-3. It is best to prepare your W-2's before completing your final 941. All W-2's and W-3 form must be issued by Jan. 31,1998.
- Effective immediately contributions must be substantiated. If a donor does not have a bank recorded or written communication from the church then the donation will not be allowed as a tax deduction. No deduction will be allowed for "guessing" what your cash gifts were.
- Housing allow, included as wages The housing allowance is not wages and should not be reported in with wages on the W-2 box 1. Put the allowance in the box 14 marked "other" with a statement. included above housing allowance.
- Standard mile rates for 2022 are: \$58.5 for business miles driven. Order Mile IQ to track your miles Get reimbursed for your ministry miles.

We are most thankful for the privilege to have served 95 churches, assisted 400 Christian workers with their taxes. preached over 200 counseled over 10 families per week, and answered over 3,000 calls for help. Our biggest expense is our travel cost of \$24,961, then phone \$2,307, then office exp. of \$3,518 and \$11,245 Licenses and E&O insurance & medical insurance It is a very large expense to be licensed in every state where we freely counsel people about their finances. The CLA is recommending this and the SEC is requiring this. We want to be above reproach in our ministry; therefore, whatever the cost it is not too high for integrity. There has never been a fee for our ministry, nor do we want to change. Only through God's help and the faithful support of many Christians has all this been possible. We are thankful to the Lord for His protection and mercy. Our vehicles have over 100,000 miles on them because of our ministry. Thank-you for your prayers of protection. When we look back over the year and see what the Lord has done with people as flawed as we are, we are amazed.
