Lazy River Furniture (Bid #26.002)

- 1. General: Vendors should meet minimum specifications on the Pool Furniture listed and will be given credit for exceeding the specifications.
- 2. Vendor Qualifications: To qualify to submit a bid, vendors must have over \$5,000,000 in annual sales and must not rely on $3^{\rm rd}$ party warranty except where the vendor is acting on behalf of the manufacturer that provides their own warranty service. Warranty must include coverage for a minimum of 3 Years. Vendors must have been conducting business selling Outdor Furniture for at least 10 years.
