In order to process your permit, all items listed below should be completed and ready when we pick you up for your first appointment.

- If you are 17 yrs or older you must have six points of ID
- **Completed green application card** – if of the required fields are left blank, the application will not be processed. only student must sign on the bottom of green application by X ,

Top section labeled 'Driver's License Number' must be left blank

- **Parent / Guardian must print their name and sign by parental section on the green application card .**

- **Check / Money order required:**

- **Two checks must be made separately** – you must bring a personal check or money order payable to the following:

- **Permit application fee for \$10.00 payable to NJ Motor Vehicle Service**

- **Special Sixteen** – \$_____ cash, check, or money order payable to **All American Auto Driving School** for 6 hours of behind the wheel training and permit service

- **student need to purchase red decals** and the fee is \$5. if they do not purchase it during the beginning of the six hour will have to pay \$15 inconvenient fee. you can add the fee to **All American Auto Driving School**.

- **Parent / Guardian must sign agreement attached.**

- **Original Birth Certificate** with original seal **or** valid passport (Notarized copies or hospital birth certificate are not accepted)

- **copy of social security card.**

- Foreign Students must bring their alien card or citizenship certificate or American passport. (Foreign birth certificates are not accepted)

- Students that have completed and passed a Driver's Education Program should bring their graded test card

- If you wear glasses or contacts, be sure to wear them the day of eye testing.

Driving School Student Agreement

APPOINTMENTS MUST BE CANCELLED 24 HOURS IN ADVANCE OR STUDENT WILL BE CHARGED IN FULL FOR THAT LESSON. The cancellation must be made during normal business hours at the school phone number listed above. No cancellation will be accepted after 5pm Friday for Saturday or Sunday lesson. Appointments must be mutually agreed upon for date, time, and location.

Road lesson will **ONLY** be given in a driving school vehicle. The vehicle to be used for instruction has () automatic transmission () standard transmission, and shall be equipped with, at minimum, a brake for both the instructor and the student.

If a check payment made to All American Auto Driving School is returned for any reason, there is a fee of \$25.00 per returned check. The amount due must be paid in **CASH** or **MONEY ORDER** along with any court or attorney fees.

No fees will be charged other than those specified above. This constitutes the entire agreement between the school and the student and no verbal statements or promises will be recognized. The student may rescind this agreement within 72 hours of the first lesson and upon such rescission shall receive a refund for any lesson or service not conducted or provided.
