

SUMMER LEASE REQUEST FORM

Summer lease agreement is the same as "CURRENT" lease (either 25-26 lease or 26-27 lease). **Please circle the Summer Term that applies to you. This form must be signed and submitted to our office by April 17, 2026. If your request is approved, we will call to schedule an appointment to sign a Summer Lease Agreement by April 27, 2026.** Please refer to current lease agreement for all provisions, including rules and regulations with the exceptions as follows:

- 1) Summer Term: 25-26 Lease – May 19, 2026 through August 7, 2026
 ***26-27 Lease – May 26, 2026 through August 19, 2026

***NOTE: First summer session begins on May 18, 2026.
Last summer session ends August 14, 2026.
These dates may be outside our terms above.

Rent: \$850.00 per person
Min/Max # Tenants: Minimum # of Tenants – 50% of Maximum # of Tenants
 Maximum # of Tenants – (See Lease/Email/Website)
Deposit: \$300.00 per person

- 2) At least **50% of the summer tenants must be from the CURRENT lease.** Any new tenant must pay \$300.00 deposit to be returned less any "documented damage", 30 days after term of Summer Lease.
- 3) Documented Damage – If damage occurs due to your negligence and/or actions, it is up to the tenants to provide to CKC RENTAL AGENCY, LLC, CKC RENTALS, LLC, CLAWSON & CLAWSON RENTALS, LLC, BEECH STREET INVESTORS, LLC and/or STEWART DEVELOPERS, LLC in writing which tenant is responsible for these damages. All summer tenants, including the responsible party, MUST sign this document. If this procedure is not followed, we will deduct the necessary charges from everyone's deposit at the end of the current lease.
- 4) Tenants of the CURRENT lease must sign the attached "**Property Release Form**" to be valid before a Summer Lease Agreement is signed, regardless of whether these tenants are living at this premise during the summer.
