This is needed for the person who needs to "pick up the pieces" when you are no longer able. Don't plan to complete the entire document in one day – it may be too overwhelming and never accomplished. Enter information a little at a time - as a statement arrives or bill becomes due.

The Red Cross Guide is a .pdf file that can be downloaded and printed if you are more comfortable with a paper document (Use pencil to enable later updates to an address, phone number, etc.). The spreadsheet is an Excel file that can be downloaded and modified. You may need to set "Enable editing" after it is downloaded.
