Statement from Rob and Jo Nickless

I wanted to make a statement regarding our position, and that of our business, in North Moreton.

Jo and I have operated our business, Meadow Honey Farm, in North Moreton at Melhuish Farm for 15 years and enjoy excellent relationships with both our current and our previous landlords. I am now disconcerted to find that our business is cited in potential enforcement investigation actions, and as a result it is now called into question whether our food premises can operate from our current location. That is despite the very same local authority recently awarding us a 5-star food hygiene rating. We will also shortly need to accommodate planning officers who are acting on an investigation case. These actions in themselves don't worry us, but they all take considerable time and effort to deal with. And any of you who know us, will recognise that we are not swamped in spare time.

To be absolutely clear with everyone, our business is as a primary food producer, and we also provide invaluable pollination services to other farms and agricultural businesses across a 20-mile radius. At its most simple, our business is agriculture. We are bee farmers, *not* beekeepers. And we operate that farming business from a farm. It seems clear to us that we should therefore be able to carry out that work, as we have done over 15 years, without unnecessary investigation or interrogation.

Since our residential move to North Moreton in 2017 our family has been actively involved in the parish – the village emergency plan, the parish council, the church, this hall, green shoots all benefit from our contributions of time, expertise and equipment. I am here today to ask for something in return for that. I'd like to ask that the Parish Council and the local community support us, as and when we need it, to enjoy our tenancy and work in the village unhindered by the continuing actions of one or two individuals.

Joint Local Plan Examination - start of public hearings on 3 June

We are pleased to update you on the latest progress of our Joint Local Plan. The dates for the start of the public hearings for the South and Vale Joint Local Plan have been published this week.

This stage of the examination involves our appointed Planning Inspectors (Inspectors R A Bust and C Mulloy) holding hearing sessions to hear from the Councils and other participants about whether the JLP is sound and has been prepared in accordance with legal and procedural requirements.

The first week of hearing dates will cover the following topics:

- Tuesday 3 June 2025: Matter 1 Procedural and Legal Requirements followed by Matter 2 The Duty to Co-operate
- Wednesday 4 June 2025: Matter 3 The Housing Target/Requirement
- Thursday 5 June 2025: Matter 4 The Employment Land Requirement

All the hearing sessions will be held at Bee House on Milton Park, OX14 4SB. Those who made representations seeking changes to the local plan at the Publication stage in autumn 2024 may have registered with the Programme Officer by 6 May if they would like to speak at the hearings as a participant. The hearing sessions will be held in public and anyone can attend in person to watch (subject to capacity at the venue). The sessions will also be available to watch online via a livestream from Bee House.

Introducing Ridgeway Council – part of a two unitary council option for Oxfordshire and West Berkshire

Introducing **Ridgeway Council**, an ambitious proposal to create a brand-new council that delivers high-quality services, improves financial resilience and value-for-money, and ensures it is able to



maintain truly local representation.

<u>An initial proposal</u> has been submitted on behalf of West Berkshire Council and the district councils in South Oxfordshire and the Vale of White Horse for the creation of a new unitary council that would see the three areas combined. The move is in response to a government invitation following its <u>announcement in December 2024</u> to end two-tier authorities like those in Oxfordshire.

As part of the shake-up of local councils, the government has also indicated all unitary authorities will need to serve around 500,000 residents or more, which will require West Berkshire Council - which covers around 170,000 people - to merge with neighbouring councils.

Ridgeway Council forms one half of a two-unitary council proposal for Oxfordshire, with the other half made up from the district council areas of West Oxfordshire, Oxford City and Cherwell. West Oxfordshire District Council and Cherwell District Council have confirmed they will be developing the North Oxfordshire Council half of the proposal, strongly complementing the Ridgeway Council work being carried out by West Berkshire, South Oxfordshire and the Vale, coming together to create a proposal for two unitaries covering what is currently Oxfordshire and West Berkshire.

With strong demographic and economic similarities and significant historic ties between West Berkshire, South Oxfordshire and Vale of White Horse, the three councils began discussions to explore the possibility of coming together as one single council. All three councils have now produced a detailed interim proposal document, which is available on their new website dedicated to keeping the public informed about the proposal at ridgewaycouncil.org.uk. The proposal is being developed under the title 'Ridgeway Council' - named after the-famous 5,000-year-old trail that travels through the heart of the three council areas.

At their Executive and Cabinet meetings last month, members from all three councils agreed to support the submission of the interim proposal. Following the government's request that Oxfordshire authorities submit interim proposals together, the county council has submitted an outline proposal for the Ridgeway Council and North Oxfordshire Council to the government alongside two other options being developed in Oxfordshire.

Speaking about the proposals <u>Councillor Jeff Brooks</u>, <u>Leader of West Berkshire Council</u></u>, said: "This initial proposal is the result of some very positive and productive discussions, and I am delighted it has been submitted to the Government for their consideration. There is more work to do on the proposal and, importantly, that includes engaging with and listening to our residents and partners. It is an exciting proposal and one which I believe will serve our communities very well for future generations."

Councillor David Rouane, Leader of South Oxfordshire District Council, said:

"We've been working hard on our interim proposal for a new 'Ridgeway Council' to provide a financially sustainable future for local government in our area in a way that reflects the shared needs and ambitions of all three existing councils. We're very pleased to submit this interim proposal to the government and look forward to engaging with our communities in the coming months to hear their views before we submit our final proposal."

Councillor Bethia Thomas, Leader of Vale of White Horse District Council, said:

"It makes good sense to base this proposal on the entire geographies of existing councils that provide high-quality, cost-effective and efficient services. Combining our strengths



would create a modern and robust local authority that puts people first and ensures our communities are served by a council that is focused on the needs of our areas, which are very similar in nature. It will be financially robust and able to ensure that the needs of all residents are met, including those with complex needs."

The government has set a deadline for final submissions for unitary council proposals no later than 28 November 2025. In the meantime, the councils will continue to develop the proposals along with a programme of communication and engagement to ensure local voices and community needs are reflected in the proposal and will also continue working positively and collaboratively with the other authorities in Oxfordshire.

If the final proposal is accepted the government's indicative timeline sets out that the new council could go live in 2028.

Oxfordshire County Council's submission to the government this week also included an initial proposal for a single unitary council for Oxfordshire, and a third option from Oxford City Council proposing the area is divided up into three small unitary councils based around an expansion of the city's borders that hasn't yet been defined.

Reducing need for temporary accommodation part of new homelessness consultation

Minimising the use of temporary accommodation which can be disruptive to people's lives, especially for children, is one key aim of proposed updates to how councils tackle homelessness in South Oxfordshire and the Vale of White Horse.

Increasing the provision of genuinely affordable, long-term homes remains a core focus of South Oxfordshire and Vale of White Horse district councils' work to reduce homelessness and end rough sleeping.

The councils are now inviting people to have their say on proposed objectives for the new strategy to reflect changes in homelessness and lay out their plans.

Plans include identifying issues early on such as 'hidden homelessness' and sofa surfing - as eviction by family and friends is the top reason for home loss in the districts. The councils will continue to work closely with every individual at risk of homelessness to help them find sustainable accommodation.

Whilst the numbers of people sleeping rough are relatively low in South Oxfordshire and the Vale of White Horse, the councils are committed to continue doing all they can to end rough sleeping by preventing it wherever possible. The council's outreach team will continue to proactively identify any rough sleepers without delay, ensuring that they receive advice from the councils' dedicated team.

Supporting rough sleepers who have complex needs through continued partnership work is an important area of the strategy. By strengthening close, collaborative working with partners in health, criminal justice, the Department for Work and Pensions, social care services and local agencies, the councils will help those who are vulnerable and have multiple needs.

The consultation is now open and runs until 11.59pm on 16 June.

The appointments were confirmed at the council's annual meeting on Thursday 15 May. At the meeting councillor members also elected <u>Cllr Katherine Keates-Rohan</u> as Chair of the Council for the year, taking over from Cllr Kellie Hinton. <u>Cllr Andrea Powell</u> was appointed as Vice Chair.

During the meeting, Cllr Rouane also delivered his latest Leader's report to council.

Work to create accessible moorings on the River Thames at Wallingford is now complete

Over £209,000 has been invested in major accessibility improvements at the riverside in Wallingford.

The project has been managed by South Oxfordshire District Council, with the support and eager anticipation of the local volunteer-run charity, Wallingford Accessible Boat Club.

The package of improvements has been designed to be step-free to provide easy access to people of all disabilities and to enhance the whole riverside as an attractive destination for residents, visitors, clubs and river users alike.

Work has covered improvements to the existing access path, roadway, ramp and moorings at the riverside – in addition to the installation of an accessible pontoon designed for river lovers with a disability.

Whilst the facility is available to all, it has been specifically designed to meet the requirements of the Wallingford Accessible Boat Club's wheelyboat, WOW-one, to enable disabled and less mobile people to have equal access to the river. To support the Wallingford Accessible Boat Club's activities, the site includes a wheelchair accessible cabin with access to water and electricity. The ambition is to create cheerful artwork on the cabin to brighten up the area.



In a related project, a Changing Places accessible bathroom has also been created at the riverside, next to the existing toilet facilities and is now available for use.

The completion of the work times perfectly with the summer opening of the Riverside site. The popular campsite opened at the beginning of May and the outdoor pool and splash pad will follow later this month.

An experienced civil engineering firm, Greenford Ltd, who are based in Wheatley, completed the work on behalf of the council. The project has been financed by £209,534 of CIL (Community Infrastructure Levy) money, charged by South Oxfordshire District Council on new development in the district. This refurbishment work follows a £400,000 boost of the onsite wash facilities and a revamp of the splashpads in 2023.

<u>Riverside Park and Pool</u> are run by GLL on behalf of the council, whilst South Oxfordshire District Council owns and manages the park and moorings at this site.

Wallingford bathing

The bathing season in England has started, and this means that from 15 May, regular tests will be carried out on water samples from the River Thames at Wallingford throughout the summer.

Since Wallingford Beach was designated as a bathing water area last year, the Environment Agency is obliged to take weekly water samples from the site during bathing season (15 May – 30 September), test them for two types of bacteria (both of which can cause serious illness, including vomiting and fever) and publish the results within a few days.

South Oxfordshire District Council has installed a new noticeboard at the site, and this will display information about the bathing water site including details of how to find the test results. This allows swimmers and other river users to make informed choices about how they can safely enjoy the river at Wallingford.

At the end of each bathing season the Environment Agency then gives a classification depending on the results of that year. Bathing water sites can be classified as 'excellent', 'good', 'sufficient' or 'poor', based on the analysis of levels of the bacteria, E. coli and intestinal Enterococci, found in the samples.

Following testing during its first season in 2024, Wallingford Beach was classified by the Environment Agency as 'poor'. Analysis of the samples showed that there were high levels of bacteria on two occasions during the weekly testing over the five months of testing. A poor bathing water classification means the water at a designated bathing site has not met the minimum standards set by the Bathing Water Regulations. It indicates a potential health risk for people who bathe in the water, and sites with this classification, such as Wallingford, are marked with a sign advising against bathing. This does not mean that bathing is banned, sites remain open for people to enjoy as they choose to. River users are always advised to check up to date data sources to help understand the current water quality and, links to these data sources have been provided on the new sign.

Summer fun comes to Riverside

The pool and splash pad at Wallingford Riverside are set to open later this month on Saturday 24 May,



kicking off a summer of fun for families and fans of outdoor swimming in South Oxfordshire.

The Riverside Park and Pools which is owned by South Oxfordshire District Council and managed by their leisure contractors GLL, is being prepared ready for everyone enjoy this Summer.

The Riverside campsite is now open to welcome campers for the new season. The site has seen some exciting upgrades since last year, including new accessible mooring and associated paths and ramps, a new Changing Places accessible bathroom - providing better accessibility to all Riverside visitors including wheelchair users .

The pool will offer popular activities such as aqua aerobics, swim for fitness, adult and children swimming lessons, swimming Dr sessions and more.

Following the success of last year's event, Riverside will once again host the 'End of Season Dog Swim', where dogs can take a splash in the pool accompanied by their owners.

The splash pad will be available to use daily from 9am to 6pm until early September.

The pool will be open from 7am to 6pm weekdays and 9am to 6pm at weekends.

The campsite can be booked via the Better UK website and bookings for the pool will open 7 days before for members and 5 days for non-members.
