Recent HSE Business Prosecutions UK

The Health and Safety Executive (HSE) has been actively prosecuting businesses for various safety-related offenses in the UK. Here are some of the recent prosecutions and the associated fines:

Fatality: A fatal injury at a West Yorkshire plant hire company led to a £433,550 fine. The forklift had not undergone a full inspection after repairs.

Firing Range Incident: A worker was shot and paralyzed during ammunition testing, resulting in a £200,000 fine.

Poorly Maintained Pipework: An employee's lower leg was amputated due to crush injuries caused by heavy metal sheets. A £200,000 fine followed.

Electrical Flashover: A wind farm management services company was fined £80,000 after a worker was seriously injured by an electrical flashover.

Construction Industry: A construction company was fined £1.2 million after a worker fell through a fragile roof panel, suffering fatal injuries.

“These cases highlight the importance of maintaining high standards of safety and compliance to prevent serious injuries and fatalities in the workplace”.

Appointed Persons Advisory Service

1. Every employer shall, subject to paragraphs (6) and (7), appoint one or more competent persons to assist him in undertaking the measures he needs to take to comply with the requirements and prohibitions imposed upon him.
2. Where an employer appoints persons in accordance with paragraph (1), he/she shall make arrangements for ensuring adequate co-operation between them.

The Health and Safety at Work Act 1974 Section 2(3) requires employers to prepare and as is often as necessary revise the health and safety policy where the employer has 5 or more employees. The health and safety policy must be reviewed if there are any significant changes to the business.

Intermediate Level is for anyone with over two years' experience in fire risk assessing. The Intermediate Level application involves a 3-stage internal certification process. The first part of this process is a fire risk assessment check, followed by a competency assessment and finally the completion of a RPEL checklist.
