Who We Are

NYSDRA serves as the coordinating association for New York State's pioneering network of Community Dispute Resolution Centers (CDRCs)—20 centers spanning all 62 counties. Our membership brings together this CDRC network with volunteers, individual practitioners, and conflict management professionals from diverse industries and backgrounds.

As both a membership organization and program administrator, we coordinate essential dispute resolution services that reach over 74,000 New York residents annually. Through our partnership with CDRCs and individual practitioners, we ensure these services remain accessible to all New Yorkers—irrespective of income, race, ethnicity, citizenship status, language spoken, or physical or cognitive challenges. Our programs and services are specifically designed to be responsive to individualized local community needs while maintaining the highest standards of quality and professionalism.

Our Mission

(NYSDRA) is a not-for-profit membership organization committed to promoting quality conflict management and peaceful dispute resolution throughout New York State. Through leadership, education, advancement of professional standards and training, and development of innovative statewide programs, NYSDRA provides opportunities for people, communities, organizations, and businesses to effectively respond to conflict, repair harm, and build stronger connections.


Our History

Founded in 1985, NYSDRA emerged from the groundbreaking Community Dispute Resolution Centers Program created through Article 21A of the Judiciary Law in 1982. What began as an informal association of CDRC Directors has evolved into a dynamic statewide organization managing multiple dispute resolution programs for state and federal agencies.

Our growth reflects our responsiveness to community needs. In 1989, we secured our first state contract with the Division of Housing and Community Renewal. Throughout the 1990s and 2000s, we expanded our portfolio to include the Lemon Law Arbitration Program, Special Education Mediation, the New York State Agricultural Mediation Program, and Early Intervention Services. In 1996, recognizing the evolution of the field, we expanded membership beyond CDRC directors to include volunteer mediators and private practitioners—creating a richer, more collaborative professional community.

For nearly four decades, NYSDRA has served as both coordinator and innovator, strengthening New York's dispute resolution infrastructure while maintaining our founding commitment to accessible, high-quality services that help communities resolve conflict peacefully.


Our Statewide CDRC Member Network

NYSDRA Financial Overview




NYSDRA's diverse portfolio of programs continues to demonstrate strength and momentum, positioning the organization for sustained impact and future expansion.

Disability-Related Mediation Programming (ACCES-VR, Early Intervention & Special Education)

ACCES-VR Mediation Program

Adult Career and Continuing Education Services-Vocational Rehabilitation (ACCES-VR) starts with the presumption that all individuals with disabilities can benefit from vocational rehabilitation services and should have opportunities to work in jobs integrated within their communities. Vocational Rehabilitation Counselors guide individuals through service programs they need to reach their employment goal.


Early Intervention Mediation Program

The Early Intervention Mediation Program was established in 1993 to provide services for infants and toddlers, ages 0-3 years old, with developmental delay or disabilities and their families. Title II-A of Article 25 of the Public Health Law establishes the right of a parent who disagrees with the determination of an evaluator or Early Intervention official to mediation and/or an impartial hearing to resolve their dispute.

Special Education Mediation Program

Special education mediation is a resource for parents of children with disabilities and school representatives to work out differences in a collaborative way. Mediation is a voluntary, confidential process facilitated by a qualified, impartial mediator. It provides a safe space where parents and schools are empowered to develop agreements focused on the best interest of the child.

- The mediator helps to clarify the interests of the parties, which improves communication;
- Each person will have an equal opportunity to express viewpoints and concerns;
- Possible resolutions, within federal and state regulations, will be explored;
- In many cases, the mediator is able to help develop a solution that is acceptable to both parties; and
- Brings together the consumer and an ACCES-VR representative to share concerns and points of disagreement.
- Your Initial Service Coordinator (ISC) will talk with you about your concerns for your child's development;
- They will also explain how your health insurance can be used and that early intervention services will be at no cost to you;
- Help you resolve any problems that might come up, including disagreements about the service(s) your child might need;
- The Individualized Family Service Plan, or IFSP, is a written plan that will be specially designed for you, your child, and your family that outlines and explains the El services your child and family will receive;
- A transition plan must be developed for all children leaving the EIP, including going to Preschool Special Education or other services, on or close to their third birthday.
- Mediation is free to the parent and school district;
- The mediator helps to clarify the interests of the parties, which improves communication;
- The mediator helps identify the sources of the conflict and addresses underlying issues;
- The parties agree to solutions they create, increasing the likelihood of compliance;
- Mediations are less expensive, less negative, and are resolved faster than impartial hearings; and
- The goal is to reach a mutually acceptable agreement which is legally binding and enforceable in court.

Disability Mediation Program Statistics

- While the amount of cases received per month may fluctuate, the Special Education mediation program continues to manage roughly 400 cases per year.
- The Special Education program receives more cases than any other program that NYSDRA manages.
- The majority of the disability mediation cases received through this program are based in Kings and New York counties.

- The majority of the mediations at the CDRCs are held virtually, though all of the centers still offer in-person mediations.
- On average, a Special Education case takes approximately 45 days to reach a resolution. This timeframe includes the acceptance of the case by the CDRC, the scheduling of the mediation, the mediation itself and the rendering of the mediation agreement.
- Some cases may settle prior to mediation, without a mediation agreement.

NYSDRA's Administration of the New York State Lemon Law Arbitration Program

New York State has strong consumer protection laws—known as the New Car, Used Car, Wheelchair, and Farm Equipment Lemon Laws—that provide recourse for consumers who purchase or lease a vehicle or covered equipment that repeatedly fails to meet the terms of the written warranty. When a manufacturer or its authorized dealer cannot repair the defect after a reasonable number of attempts, buyers may be entitled to relief, including a refund or replacement.

NYSDRA is proud to administer the state's Lemon Law Arbitration Program on behalf of the New York State Office of the Attorney General (OAG). While other entities may offer mediation or arbitration options, the program administered through NYSDRA is the only one that operates under the authority of the Attorney General. As a result, arbitration decisions issued through this program carry the full weight of the State of New York and are legally binding and enforceable.



One of the program's greatest strengths is its accessibility. Participation is not dependent on whether a dealer, manufacturer, or leasing company is affiliated with the Attorney General's program. If a consumer has a qualifying claim, the business is subject to the arbitration process—any dealer or manufacturer in New York State can be required to participate, even if they have never interacted with the program before.

To qualify, the vehicle or equipment must simply be purchased or registered in New York State, making the program widely available to consumers throughout the state. By administering this program, NYSDRA provides an efficient, neutral, and affordable pathway to resolution—ensuring that New Yorkers can enforce their rights without navigating the court system.



Lemon Law Arbitration Program Statistics

- The Lemon Law Arbitration Program manages approximately 350 cases each year, with monthly volume fluctuating based on seasonal vehicle purchases and warranty timelines.
- In 2023, the Lemon Law program expanded to include New Farm Equipment, allowing consumers to seek relief when newly purchased farm machinery does not conform to manufacturer warranty standards.
- Nassau and Suffolk counties represent the highest case volume in the state, with more than 800 cases filed from these two counties alone since 2017.

- Most hearings are conducted virtually, providing consumers and manufacturers with a convenient and efficient process, though in-person hearings remain available at all Community Dispute Resolution Centers (CDRCs).
- Cases are typically resolved within 45 days, from case acceptance by the Attorney General's Office through scheduling, hearing, and issuance of the arbitration decision.
- Consumers may choose a replacement vehicle instead of a refund. Since 2017, more than 150 cases have resulted in a replacement vehicle.

NYSDRA's AmeriCorps Program

Community Mediation Service Corps (CMSC)

The Community Mediation Service Corps (CMSC) is funded by AmeriCorps and administered by NYSDRA in partnership with New York's Community Dispute Resolution Centers (CDRCs). The program cultivates the next generation of community-based conflict resolution practitioners through structured training, mentoring, and hands-on service.

Each service year (September-August), CMSC Members are placed at CDRC host sites across New York State. Members work directly with their Host Site Supervisors to support the unique needs of the community where they serve. While the focus of their day-to-day work varies by location, every Member participates in one of three AmeriCorps service tracks:

AmeriCorps Program Tracks

- 1. Youth Services Conflict Resolution Specialist
- 2. Capacity Building Specialist
- Family Services Specialist (including Custody/Visitation cases)



Regardless of track, all CMSC Members receive extensive training to build their competencies as mediators and conflict resolution practitioners. Training combines foundational ADR skills with specialized learning experiences and supervised practice.

Training Opportunities Include:

- Initial Mediation Training
- Conflict Coaching
- Restorative Circles
- Custody & Visitation Mediation

Through this combination of service, mentoring, and skills development, CMSC Members support conflict resolution services in their host communities while developing pathways to careers in Alternative Dispute Resolution.



Community Mediation Service Corps (CMSC) AmeriCorps Events




The AmeriCorps 2024 NYC Summit brought together AmeriCorps members, alumni, and community leaders for an inspiring day of service and collaboration. Set against the dynamic backdrop of New York City, the event featured impactful keynote speakers, skill-building workshops, and meaningful networking opportunities.

Attendees worked together to share innovative solutions to pressing community challenges while celebrating the profound impact of national service. The summit was a powerful reminder of AmeriCorps' commitment to empowering individuals to drive positive change.



The AmeriCorps 2024 Professional Development Conference in Lake Placid was an inspiring event that brought together service-driven individuals from across the state. Nestled in the scenic Adirondacks, the event featured compelling keynote addresses, interactive workshops, and ample opportunities for collaboration and reflection.

Participants explored innovative strategies for tackling community challenges and shared inspiring stories of service. The conference highlighted the power of collective action and reaffirmed AmeriCorps' dedication to building stronger, more resilient communities.



The interest on IOLA accounts is pooled and provides the money for grants made by the Board of Trustees of the IOLA Fund to non-profit civil legal services providers across the state. IOLA's current two-year grant cycle will provide \$70 million in grants for providers of civil legal aid to low-income New Yorkers, furthering the goal of equal access to justice for all.

Thanks to IOLA, NYSDRA and the CDRCs collectively served more than 51,000 New Yorkers through over 19,000 cases in FY2024, providing timely, accessible, and community-based dispute resolution services that offer an alternative to litigation and promote peaceful resolution of conflict.

IOLA Grant Initiatives @ NYSDRA

The IOLA grant provides critical support that enables NYSDRA to strengthen New York's statewide network of Community Dispute Resolution Centers (CDRCs) and expand access to justice for all New Yorkers. IOLA funding allows NYSDRA to:

- Subgrant funds to the CDRCs to support mediator recruitment, training, and community outreach efforts.
- Ensure language access by funding statewide LanguageLine services so residents can participate in mediation regardless of the language they speak.
- Invest in technology that improves service delivery, including development and implementation of the Online Contract Reporting System (OCRS), which reduced administrative processing time by over 90% and strengthened data accuracy across all programs.
- Support professional development and training, including Basic Mediation Training, advanced skills workshops, and continuing education programs for volunteers, mediators, and legal professionals.
- Enhance community awareness of dispute resolution services through outreach and education, including digital marketing campaigns and legal information resources to help individuals understand their options.
- Maintain and expand collaborative partnerships with courts, state agencies, community organizations, and legal service providers to ensure that mediation services are integrated into New York's broader accessto-justice system.

NYSDRA's Special Education Mediation Program

Special Education Dispute Resolution Center



NYSDRA was awarded a five-year contract from the New York State Department of Education Office of Special Education to create the Special Education Dispute Resolution Center (SEDRC).

The contract calls for the development of a virtual center which will provide professional development for special education mediators and other stakeholders; administration of a centralized system to oversee requests for and intake of special education mediations across New York State; provide reimbursement of mediation administrative costs to New York State's Community Dispute Resolution Centers (CDRC); and collect and report data on special education mediation sessions conducted throughout New York State.

During the 2023-24 school year, Community Dispute Resolution Centers (CDRCs) played a crucial role in supporting families and schools by responding to 455 requests for mediation, resulting in 286 mediations held across New York State. These efforts helped facilitate constructive dialogue and resolution in special education disputes. Looking ahead, the Special Education Dispute Resolution Center (SEDRC), administered by NYSDRA, will focus on expanding the use of mediation as a proactive approach, fostering collaboration to better support students, families, and educators.

On Day 2 of the Annual Conference, NYSDRA proudly honored Sarah Rudgers-Tysz with the prestigious Andrew Thomas PeaceBuilder Award. The ceremony took place at the Albany Marriott.

As the Executive Director of Mediation Matters, Sarah has championed communitybased dispute resolution for Albany, Rensselaer, Saratoga, Schenectady, Warren, and Washington Counties.

Her leadership and dedication have been instrumental in strengthening community partnerships, creating impactful conflict resolution programs, and expanding access to mediation across New York.

About the Andrew Thomas Peacebuilder Award

The Andrew Thomas Peacebuilder award was established in 1996 to honor Tekaronianeken Jake Swamp, Sub-chief of the Wolf Clan for the Mohawk Nation and Director of the Tree of Peace Society. A lifelong advocate for peace, Chief Swamp promoted unity within his culture and beyond, participating in historic events like Wounded Knee and the Akwesasne Bridge Blockade and planting peace trees around the world to share the contributions of the Haudenosaunee Confederacy.

In 1998, the award was renamed to honor Andrew Thomas, NYSDRA's first president and a pioneer in dispute resolution. Thomas led efforts in social justice reform and mediator training, empowering thousands through his leadership as Executive Director of Rochester's Center for Dispute Settlement and as cochair of the National Association of Community Mediation.
