Achievements/accomplishments denote chamber activity that intentionally resulted in positive measurable results, including (but not limited to):

- A business development initiative
- An economically impactful effort
- A new program or event
- A community improvement project

<u>Organizational excellence</u> will be evaluated in each of the areas of: **Membership, Programs, Planning and Finance.**

All members of CPO in good standing are eligible to apply.

Applications

Along with supporting documents, submitted with the application must be two (2) essays (both double-spaced):

- An essay (1 page max) on organizational excellence
