If you want to arrange a direct cremation, you may use an unfinished wooden box or an alternative container. Alternative containers can be made of heavy cardboard, pressed wood or composition materials (with or without outside covering), or may be pouches of canvas or other materials. The direct cremation prices do not include the crematory charge.
