**GENERAL PRICE LIST**

These prices are effective as of October 1, 2025 and are  
subject to change without notice.

The Federal trade commission (FTC) and the New York State Department of Health both require that certain disclosures be made by the funeral providers on the General Price List. Although these disclosures are similar, they are not exactly the same. This General Price List contains both sets of the required disclosures. The disclosures required by the FTC, when different from those required by the Department of Health, are preceded by the letters "FTC."

The goods and services shown below are those we can provide our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our services. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral services and merchandise you selected.

This list may not include prices for certain items that you select, such as cemetery charges or crematory services, flowers and newspaper notices. The estimated or final prices for those items will be shown on the itemized statement describing the funeral services and merchandise you selected. We charge you for our services in buying certain items.

"The goods and services shown below are those we can provide to our customers. You may choose only items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected."



**ALTERNATIVE SERVICES:** *The charges for direct cremations and burials include only the items listed in the following description.*

<b>A. Direct Cremation</b>	<b>\$2,325. to \$2,475.</b>
1. With a Container provided by purchaser	\$2,325.
2. With an Alternative Container (Cardboard Container)	\$2,475.

(FTC) "If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The container we provide is a corrugated container."

*Our charge for a direct cremation includes local transfer of remains to the funeral home, required authorizations, services of the funeral director and staff, transportation of the body to the local crematory and the return of the cremated remains to the funeral home. Transfer or other transportation by the funeral home beyond a radius of 20 miles is subject to an additional charge of \$2.50 per mile. **If you want to arrange a direct cremation, you may use an unfinished wooden box or an alternative container. Alternative containers can be made of heavy cardboard, pressed wood or composition materials (with or without outside covering), or may be pouches of canvas or other materials. The direct cremation prices do not include the crematory charge.***

<b>B. Direct Burial</b>	<b>\$2,900. to \$3,050.</b>
1. With a Container provided by Purchaser	\$2,900.
2. With an Alternative Container (Cardboard Container)	\$3,050.

*Our charge for a direct burial includes the local transfer of the remains to the funeral home, required authorizations, services of the funeral director and staff, and transportation of the body to the local area cemetery. Transfer or other transportation by the funeral home beyond a radius of 20 miles is subject to an additional charge of \$2.50 per mile. **The direct burial prices do not include cemetery charges.***

**Transfer of Remains:** *(to the funeral establishment including personnel, equipment and vehicle within a 20 mile radius), (\$2.50 per mile charge beyond local radius.)* **\$550.**

(FTC) "Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not required you to pay for it, such as direct cremation or immediate burial."

*In New York State, embalming is not required by law. If you do not want embalming, you have the right to choose an arrangement which does not require you to pay for embalming, such as direct cremation or direct burial. If you select certain funeral arrangements, such as viewing or open casket funeral, embalming may be required by the funeral firm.*

**Other Preparations of the remains: (excluding embalming)**

*Preparation of the remains, unless selected, is not required for direct cremation or for direct burial.*

## Arrangements

\$1,875.

Basic arrangements including funeral director, other staff, equipment and facilities, to respond to the initial request for service, the arrangement conference, securing of necessary authorizations and coordination of service plans with parties involved with the final disposition of the deceased. Also included in this charge are overhead expenses relative to our facility such as insurance, building and utility expenses, parking lot and grounds maintenance, taxes, equipment, furnishings, inventory costs, recordkeeping and secretarial and administrative expenses.

(FTC) "This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains)."

***The charge for our services will be added to the total cost of the funeral arrangements you select.***

***However, this charge will not be added to the cost of a direct cremation, direct burial, forwarding of remains or receiving of remains because the prices for those services include this charge.***

## Food and Beverage Policy:

We are happy to allow food and beverages to be served at our facility during services. This includes non-alcoholic beverages, tea, coffee, light refreshments including but not limited to prepackaged snacks, deli platters, baked goods and the like. Hot food or foods that need refrigeration are not permitted.

*All livery prices below are local rates within a 20 mile radius. Additional mileage, outside that radius, will be subject to a charge of \$2.50 per mile.*

## Limited Services:

### Forwarding of Remains to Another Funeral Home

\$2,775.

This charge includes the transfer of the remains to the funeral home, staff services, securing necessary authorizations, local transportation within 20 miles to point of shipment. Transportation beyond local point of shipment will be billed either as livery or common carrier charges, depending on forwarding location. The charge does not include shipping charges or additional items of services, merchandise, facility use, and livery that the customer may wish to select.

### Receiving of Remains From Another Funeral Home

\$2,735.

This charge includes basic transportation of the remains to the funeral home and/or place of local disposition, staff services, and securing necessary authorizations. The charge does not include additional items of service, merchandise, facility use and livery that the customer may wish to select. Transportation beyond local place of disposition will be billed as livery charges. Local place of disposition is within 20 miles.

## Cash Advances:

Services and merchandise provided as cash advanced items will be billed at the same amount paid by the funeral firm.

## Payment Policy:

Often the death of a loved one is untimely and we try to make all options available to help you with payment. We are a small business and rely on timely payments to serve our families. Cash advance items (third party charges) as well as 50% of the remaining balance is due on the day of services. The remaining balance is due in full 30 days from the date of service. A late charge will be added to any balance not paid according to our terms of 1.5% per month (18% per year).

We accept Cash, Checks, Visa and Mastercard. Life insurance policies that can be directly assigned to the funeral home are also acceptable. There will be a 3% discount offered for payments made by cash or check. This discount will not be offered toward cash advanced items.

All financial arrangements are made with the purchaser and not with the estate of the deceased.
