REFLECTION – REFLEXIÓN

Luke 18, 1-8

"I charge you in the presence of God and Christ Jesus, who will judge the living and the dead, and by his appearing and his kingly power, proclaim the word, be persistent, whether it is convenient or inconvenient; convince, reprimand, encourage through all patience and teaching... remain faithful to what you have learned and believed, because you know from whom you have learned it."

Although Paul wrote this letter to Timothy, why not consider it to be a message personally sent to you. We can all seek to let God's inspired word change our lives, even at some cost, if it brings us closer to the Lord. Am I convinced that the Lord is speaking to me? Do I see something that I must change and correct in my life? Am I able to be a source of encouragement for someone else who is down or wandering?

As I hear the word and reflect upon it, remember the prophetic statement, 'Speak Lord, your servant is listening.'

Lucas 18, 1-8

"Yo te conjuro delante de Dios y de Cristo Jesús, que ha de juzgar a los vivos y a los muertos, y en nombre de su Manifestación y de su Reino: proclama la Palabra de Dios, insiste con ocasión o sin ella, arguye, reprende, exhorta, con paciencia incansable y con afán de enseñar ... Pero tú permanece fiel a la doctrina que aprendiste y de la que estás plenamente convencido: tú sabes de quiénes la has recibido."

A pesar de que San Pablo escribió esta carta a Timoteo, ¿por qué no lo consideramos como un mensaje enviado personalmente a nosotros? Podemos esperar que la palabra inspirada por Dios cambie nuestras vidas, aunque nos cueste, si nos lleva más cerca al Señor. ¿Estoy convencido de que el Señor me habla? ¿Veo algo que debo cambiar y corregir en mi vida? ¿Soy capaz de ser fuente de aliento

para alguien que necesita ayuda, que está de bajón?

Al escuchar la palabra y reflexionar sobre ella, recuerde el dicho profético: 'Habla, Señor, tu siervo escucha.'

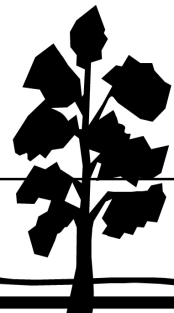
