- Any discussion, payment and the final collection of balls must be completed during the allocated time of the lesson.

Private Lessons:

- The fees for the lessons cancelled during the term, additional lessons had during the term and holidays will be adjusted on the following term invoice.

- Cancellations must be made with 24 hours notice at no charge, Students will be charged the full cost if they fail to show up without notice of cancellation.
- Students will be required to give four weeks notice to terminate lessons.

Group Lessons:
