Storm Water Permitting- Mr. Showalter reported SDE submitted the Annual MS4 Report to DEP which was due by September 30, 2025. A copy of the report was provided to the Borough Manager.

<u>Community Park Restroom Building Grant Project</u>- Mr. Showalter reported bids were received via PennBid and reviewed the preliminary bid results. Bid results were as follows:

Contract A (General)- The apparent lowest responsible bidder is Easton General Contractors (Easton, PA) with a Total Bid Amount \$188,084.00. There were a total of 8 bidders with bids ranging from \$188,084 to \$461,831.

Contract B (Plumbing, HVAC, and Mechanical): The apparent lowest responsible bidder is John G. Membrino Construction (Hereford, PA) with a Total Bid Amount \$35,062. There were a total of 4 bidders with bids ranging from \$35,062 to \$192,888.

Contract C (Electrical): The apparent lowest responsible bidder is Tri Vet Company, Inc. (Pine Grove, PA) with a Total Bid Amount \$37,600. There were a total of 3 bidders with bids ranging from \$37,600 to \$153,000.

Mr. Showalter indicated SDE will notify the apparent low bidders and request additional information for review by SDE and the Solicitor for awarding of the Contracts at the November Council meeting.

Motion by Beth Young and seconded by Dean Borrell to accept the engineer report. Carried.

Mayor Donald Raifsnider, Jr., read the mayor's report for September. This was filed on a motion by Dean Borrell and seconded by Beth Young. Carried.

Fire Chief David Feltenberger read the report from Central Fire Co. for September. This was filed on a motion by Beth Young and seconded by Jeff Calpino. Carried.
