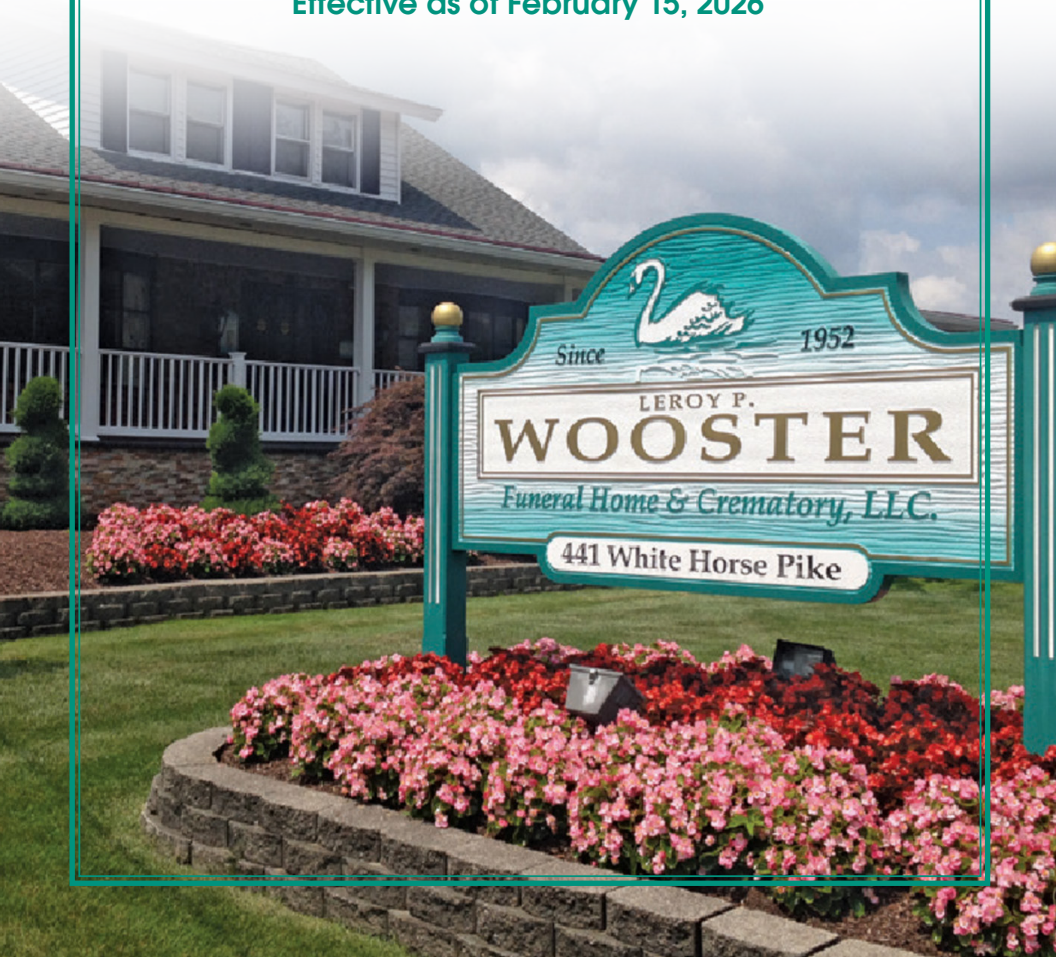

# SERVICES

## PROFESSIONAL SERVICES OF FUNERAL DIRECTOR AND STAFF

### BASIC SERVICES of FUNERAL DIRECTOR AND STAFF

Services included, but not limited to: (1) responding to the initial request for service; (2) conducting the arrangement conference; (3) preparation of biographical and statistical data; (4) examination of financial settlement options; (5) preparation and filing of papers, permits and authorizations; (6) coordination with those providing other services; (7) preparation and placement of obituary notices; (8) retention and care of remains prior to commencement of post-death activities; (9) overhead expenses relative to our facility and operations, such as occupancy, administrative and equipment costs.

This fee for our basic services will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

- **Basic services of funeral director and staff.....\$1,460**
- **Special services of funeral director and staff.....per hour \$265**
- **Filing Pennsylvania Death Certificate.....\$75**

### CELEBRANT SERVICES

(Includes family consultation, service in the funeral home and concluding remarks at the place of committal if scheduled immediately following the service.) \$350

### EMBALMING (including use of preparation room and sanitary care)

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial. If you choose to have an embalming performed, the decedent may be embalmed at a location other than this registered mortuary.

No human remains may remain unburied or uncremated in New Jersey for more than 48 hours unless embalmed or refrigerated. (N.J.A.C. 8:9-1.1)

### VIEWING OR VISITATION AT OUR FUNERAL HOME OR OTHER FACILITY

Use of facilities and staff for viewing, including setup of the visitation area, placement of remains, positioning of floral displays, and supervision and attendance during the hours of visitation.

### MEMORIAL SERVICE (without body present)

### AT THE GRAVESIDE SERVICE (whether at cemetery or crematory)

### SHELTERING OF REMAINS

This is a per day charge that will apply when the funeral home is in possession of the remains, except for those days when preparation of the remains, visitation or service take place.

### SHELTERING OF CREMATED REMAINS

The funeral home will shelter cremated remains for one year. After one year, cremated remains will be interred at a local cemetery. If the authorizing agent retrieves the cremated remains within one year, the fee will be refunded. (Disinterment from local cemetery is at the Authorizing Agent's expense).

All local transfer and transportation fees are based on a radius within 20 miles of the funeral home. Additional distance is charged at the local rate plus \$2.00 per mile.

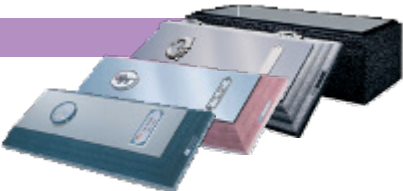

# CASH DISBURSEMENTS

## ADDITIONAL EXPENSES

Arranging the funeral ceremony and committal often requires the funeral home to pay others on your behalf. We do not charge for this service. An example of the people who may expect payment in advance include the cemetery, church/synagogue or clergy. Often the timing of the funeral arrangements—hour, date, or holidays—may make it necessary for us to estimate what advances you want us to make on your behalf.

This list does not include prices for certain items that you may ask us to buy for you, such as cemetery or crematory services, flowers and newspaper notices. The prices for those items will be shown on your bill or the statement describing the funeral goods and services you selected.

### FORWARDING OF REMAINS TO ANOTHER FUNERAL HOME

This package charge includes local transfer (within 20 miles) of remains to this funeral home, basic services of funeral director and staff, sheltering of remains for up to 48 hours, embalming, obtaining necessary permits and authorizations (but not the actual cost of death certificates, permits and filing fees) and transportation of remains to Philadelphia International Airport. It does not include a casket or alternative or shipping container, the use of facilities and staff for any visitation or ceremony—public or private—prior to forwarding the remains, or any sheltering for days on which no post-death activities occur. Nor does it include the charges of a common carrier.

### RECEIVING OF REMAINS FROM ANOTHER FUNERAL HOME

This package charge includes receiving the remains from another funeral home, transfer of remains from Philadelphia International Airport to our funeral home, sheltering of remains for up to 48 hours, basic services of funeral director and staff, obtaining necessary permits and authorizations (but not the actual cost of death certificates, permits and filing fees), local transportation (within 20 miles) to the cemetery or crematory and accompaniment of remains to cemetery or crematory by licensed funeral director. It does not include the use of facilities and staff for any visitation or ceremony—public or private—prior to burial or cremation, or any sheltering for days on which no post-death activities occur. Nor does it include the charges of a common carrier.

### IMMEDIATE BURIAL

Our package charges for immediate burial include basic services of funeral director and staff, local transfer (within 20 miles) of remains to this funeral home, sheltering of remains for up to 48 hours, obtaining necessary permits and authorizations (but not the actual cost of death certificates, permits and filing fees), local transportation to the cemetery, sanitary care, preparation of remains for identification and accompaniment of remains to cemetery or crematory by licensed funeral director. This charge does not include the use of facilities and staff for any visitation or ceremony—public or private—prior to burial, or any sheltering for days on which no post-death activities occur. Nor does it include the actual cost of the grave at the cemetery, or the cemetery's charges for opening and closing of the grave or an outer burial container (if required by the cemetery).

### DIRECT CREMATION

Our package charges for direct cremation include basic services of funeral director and staff, local transfer (within 20 miles) of remains to this funeral home, sheltering of remains for up to 48 hours, obtaining necessary permits and authorizations (but not the actual cost of death certificates, permits and filing fees), sanitary care and preparation of remains for identification. This charge does not include the use of facilities and staff for any visitation or ceremony—public or private—prior to cremation, or any sheltering for days on which no post-death activities occur. **Nor does it include the actual cost of the cremation process which is a crematory charge that is detailed below.**

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). *The containers we provide are cardboard.*

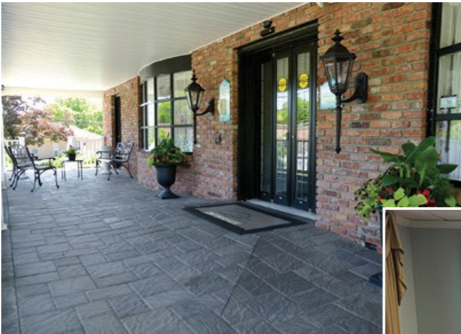
## PAYMENT POLICY

A deposit on the total amount on the accompanying estimated statement of funeral goods and services selected, categories I—V, must be paid before the close of the business day on which the funeral ceremonies fall.

Payment of the remaining outstanding balance, must be paid 30 days from the date on which the funeral ceremonies were held. Accounts are considered past due 30 days after funeral ceremonies were held and are subject to interest and penalty of 1.5% monthly (18% per annum).

## FUNERAL PROCESSIONS AND CORTEGES

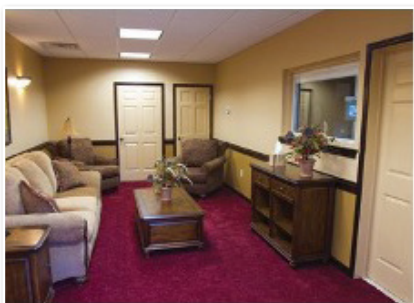
Funeral processions and corteges are NOT exempt from NJ state traffic laws and DO NOT have special permission to proceed through traffic lights and/or signals or otherwise disobey the rules of the roadway. Our funeral home DOES NOT take responsibility for any of the participating drivers of automobiles in any procession. Our funeral home may choose to identify vehicles in a funeral procession or cortege as a courtesy only. Each driver is responsible for their own actions including driving safely while in the funeral procession or cortege. We will provide directions and contact information, for the drivers, to the destination and reception, if applicable.



## THE CREMATORY

Opened in 2010, after years of planning, our new crematory allows your family to participate in the cremation process in comfort and privacy. Our stand alone building modeled after a small ranch home offers ample gathering space. Our witnessing room includes a private restroom and witnessing window.

The main part of our facility is the cremation and processing area. Viewable from our witnessing room, this area is accessible for your participation, if desired.



## CONSUMER PROTECTION INFORMATION

There are some monument/memorial dealers who, shortly after burial, contact the family and claim to represent the cemetery or the funeral home. These persons will often attempt to sell a monument to a family, receive payment and fail to deliver, or suggest that there are certain requirements for monumentation and that monuments must be placed within a certain period of time. There are no such regulations requiring you to erect a monument or inscribe an existing one

## HISTORY

The LeRoy P. Wooster funeral Home was established in 1952 by LeRoy Purley Wooster. The building was originally a large home at the corner of White Horse Pike & Cooper Folly Rd. that was converted into a funeral home and the family residence. In 1962 an extensive addition was added giving the funeral home one of the largest viewing rooms in the area. In 1972, Mr. Wooster added a crematory and the business became the LeRoy P. Wooster funeral Home & Crematory, as we know it today. This unique addition made our business one of only two funeral home operated crematories in the state of New Jersey.

In 1976, founder and owner LeRoy P. Wooster passed away unexpectedly. With the help of professionally licensed staff, his wife, Alice Wooster maintained the business until her son LeRoy P. Wooster received his funeral directors license in 1986 introducing the second generation of the family into the business. Today, over 60 years later, the funeral home continues to be owned and operated by LeRoy P. Wooster who continues his father's legacy with the help of a dedicated, caring and professional staff.
