1. Space may be limited so the following criteria will be used in the event of limited space. Advisors, parents of current 4H members, and alumni of 4H will be first to receive stalls for open horses in the event of limited space.
2. There will be a limit of 1 horse per household unless there is ample room. In the event that we have an abundance of open stalls, 2 horses will be permitted at the direction of the ACAS equine committee. (If you plan of bringin more that one horse please list below)
3. All open horses MUST have a lameness and body score by the vet Monday of fair. Time is TBD
4. All stalls must be stripped and cleaned by the 1<sup>st</sup> Wednesday following fair. In the event that this is not complete, this will result in revoking open horse privileges moving forward.
5. Open horse stalls will be all grouped together separate from the 4H horses.
6. Camping forms and rules can be found on the fair website, or in the fair book.
7. Helmets must be worn by all participants under 18 years old while on the horse.
8. All participants must follow all of the fairground's rules.
9. Participants can enter all fun shows and use the ring during open ring times.
