## **Farming is Changing**

DEFRA's updated version of its "Farming is Changing" flier has a short summary of all the schemes and a timeline of their development and roll out, as the document states subject to change. See attached.

## Farming Investment Fund Adding Value Grant - deadline dates announced.

Defra has announced a new £30 million grant fund focused on supporting farmers to process, diversify and add-value to their products. Grants of between £25,000 and £300,000 are available (up to 40% of costs) to pay for capital items (buildings, machinery, or equipment) that add value to eligible agricultural products, after they've been harvested or reared. It includes wool, hides, and skins and equipment such as retail vending machines. # Eligible agricultural products include:

- arable and horticultural crops (including food and non-food crops)
- livestock products (including dairy, meat, skins and hides)
- non-food crops (including fodder, fibres and flowers)

# The Rural Payments Agency (RPA) will prioritise funding for projects that:

- increase, improve or introduce new processing capabilities
- grow your business to improve business resilience
- process products for the first time
- shorten supply chains
- encourage collaboration and partnerships
- improve environmental sustainability

Please note the added value theme is for reasonably sized projects of at least £62,500. With the minimum grant being £25k (at a maximum rate of 40% of eligible costs), applicants will need to provide at least £37,500 (60%) in match funding. There is a two-stage application process opening from 9<sup>th</sup> June 2022 with a deadline of 21<sup>st</sup> July 2022 for first round applications.

The Network is considering running another one-to-one advice session for potential application ideas with a grant officer from RPA (1 hour slot per farming business). Please contact us if this is of interest.

#### **SLURRY INVESTMENT GRANT TO OPEN THIS AUTUMN**

This week, Defra provided more information about the Slurry Investment grant which will be launched in the autumn of 2022. This will help farmers already using a slurry system to upgrade their storage to reach 6 month's capacity. You can use the grant to:

- replace existing stores that are no longer fit for purpose;
- build additional storage, if your current storage is compliant;

#### Red Tractor – WRITTEN HEALTH & SAFETY POLICY REQUIRED

The new Red Tractor standards that came into force in November 2021 included the requirement that all farms with workers have a written Health and Safety policy. This exceeds the legal baseline which only applies to businesses with more than five employees. 
Exmoor Women in Farming Group – June visit - final reminder

# City and Guilds NPTC PA Qualifications -SAFE USE OF PESTICIDES - Monday 27th June 2022

We are coordinating the delivery of training on Exmoor for the City and Guilds courses: PA1 (Mandatory)- Foundation Course for all sprayer operators in safe use of pesticides; PA2 Foundation Course for Ground Crop Sprayers Mounted or Trailed training, on farm with tractor and sprayer and PA6 - Hand Held Applicator training at Cutcombe Market. # **NPTC level 2 Certificate of Competence in the Transport of Animals**

Date: Monday 27th June 2022 Venue: EHFN office. Cutcombe Market Time: 1.30pm. Are you looking to complete your NPTC Level 2 Certificate of Competence in the Transport of Animals by Road (short journeys) This is for anyone who transports animals as an economic activity on journeys over 65km in distance and up to 8 hours in duration. You have up to an hour to complete the assessment in the form of a multiple choice paper of 27 questions (21 correct answers required to pass). Cost: 1 species: £105 (Please note that sheep and cattle are classed as 1 species) and 2 species £125 (species listed below). # Safe Use of Sheep Dip

Venue: Stogumber area Date: Wednesday 6th July 2022 Time: 10am-2pm Cost: £120 We have received a number of enquiries regarding the above certification. If this is of interest to you and you would like to find out more. Please contact the office. Unit 1 Initial Practical Assessment is carried out on a one Candidate to one Assessor basis, using oral questions in the vicinity of a sheep dip. Unit 2 Written Paper, involving the completion of a computer based multiple choice question paper, is an assessment of the fundamental jobrelated knowledge which candidates are required to have in relation to the safe use of sheep dips before, during and after dipping. In order to pass the assessment for the Unit 2 Written Paper, Candidates must obtain at least 32 marks out of the maximum 40 marks (80%). Unit 3 Practical Dipping is a practical assessment involving the dipping of sheep and the candidate's ability to use, store and dispose of sheep dips safely. Candidates are actively encouraged to complete Unit 3 of the assessment although it is optional. Please register your interest admin@ehfn.org.uk.
