Privacy Policy

Beep Design Co. ("we," "us," or "our") respects your privacy and is committed to protecting the personal information you share with us. This Privacy Policy describes how we collect, use, and safeguard information in connection with our text messaging (SMS) program, and applies to customers and prospective customers who communicate with us by text message.

Information We Collect

When you opt in to our messaging program or communicate with us by text message, we may collect your name, mobile phone number, the content of the messages you send us, and any other information you choose to provide in the course of the conversation.

How We Use Your Information

We use the information we collect to respond to your questions, provide customer support, deliver the services you request, and manage your participation in our messaging program (including processing opt-in and opt-out requests). We do not use your information for purposes unrelated to providing and supporting our services.

Data Sharing

- Customer data is not shared with 3rd parties for promotional or marketing purposes.
- Mobile opt-in and consent are never shared with anyone for any purpose. Any information sharing that may be mentioned elsewhere in this policy excludes mobile opt-in data.

We may share information with service providers only as necessary to operate our business and deliver our services (for example, our telephone and messaging service provider), and such providers are not permitted to use your information for their own promotional or marketing purposes. We may also disclose information if required to do so by law. Mobile opt-in data and consent are excluded from any such sharing, as stated above.

Consent and Opt-In

By providing your mobile phone number and opting in to our messaging program, you consent to receive text messages from Beep Design Co. Consent to receive messages is not a condition of purchasing any goods or services. Message and data rates may apply, and message frequency will vary.

Opting Out

You may opt out of the messaging program at any time by replying STOP to any message you receive from us. You may also reply HELP for assistance or contact us directly at baylor@beepdesign.co.

Data Security and Retention

We take reasonable administrative and technical measures to protect the information we collect from loss, misuse, and unauthorized access or disclosure, and we retain it only as long as necessary to serve you and to comply with our legal obligations.

1. The messaging program consists of general conversational messaging to answer questions and provide support to customers.
2. You can cancel the SMS service at any time. Just text "STOP" to the phone number from which you received messages. After you send the SMS message "STOP" to us, we will send you an SMS message to confirm that you have been unsubscribed. After this, you will no longer receive SMS messages from us. If you want to join again, just sign up as you did the first time and we will start sending SMS messages to you again.
3. If you are experiencing issues with the messaging program you can reply with the keyword HELP for more assistance, or you can get help directly at baylor@beepdesign.co.
4. Carriers are not liable for delayed or undelivered messages.
5. As always, message and data rates may apply for any messages sent to you from us and to us from you. Message frequency will vary based on communication needs. If you have any questions about your text plan or data plan, it is best to contact your wireless provider.
