THIS YEAR, WE'VE BEEN BLESSED TO SEE GOD WORK IN SO MANY WAYS:

- Our "All in Gathering" was again a huge success. I love that this space is for our ministry teams, chaplains and partners and it's a chance for everyone to connect and feel a part of something bigger
- We had fantastic Senior Ministers' Retreat in the city. A highlight for me was connecting with many of the new ministers that have recently joined our movement
- 3 churches have received funding to plant and replant. Four of our churches have accessed the opportunity to work with Manna Consulting who is helping them assess their church health and impact
- In our leadership development space, we hosted two Edge Camps, State Youth Games had over 1,400 participants and volunteers and five churches participated in our funding program (one scholarship and four grants)
- Governance and Board Training Seminars have been a gift to many of our churches
- We provided a number of seminars encouraging our churches to upskill and professionally develop
- Lastly we praise God for Heidi Rawson from Neometrics for leading us through a very successful
 recruitment process for our new Executive Minister. I especially appreciated how thorough it was and
 how it honoured John Hutchinson all the way through

Each of these moments reflects God's faithfulness and the collective effort of our movement.

AS WE LOOK TO THE YEAR AHEAD, I'D LIKE TO INVITE YOU TO CONTINUE TO PARTNER WITH US AND PRAY:

FROM THE EXECUTIVE MINISTER

It has only been a few months since I stepped into the role of Executive Minister in May, following a two-month overlap with John Hutchinson. That period of shadowing was invaluable, and I want to thank the Board for their excellent succession process which allowed for a smooth transition. I also wish to acknowledge John's faithful and fruitful leadership over the past five years, during which he pastored the team and guided the association with wisdom and care.

A HEALTHY AND MOTIVATED TEAM

One of the greatest blessings of beginning in this role has been to inherit a healthy and motivated team at the Resource Centre. Each member of staff has demonstrated not only dedication but also a willingness to take on additional days where needed, and grow their "competency toolbox" so that we can serve our family of churches more effectively.

This year has seen a restructure of our Church Support team. We have intentionally consolidated roles, allowing Jeremy Bourdon (Next Gen & Leadership Development) and Grant Cullen (Church Planting & Collaboration) to increase to four days a week. John Hutchinson will return mid-November and continue serving on the Church Support team. This builds greater capacity and availability within the team while also positioning us to develop new initiatives such as a new WA based church health team.

CHURCH ENGAGEMENT AND SUPPORT

Since commencing in May, I have had the privilege of connecting with 33 (and counting) churches and ministers. These visits and conversations have spanned from Albany, Busso, Collie, Harvey and Vasse in the south, to Carnarvon and Geraldton in the north, to Perth-and-surrounds in Como, Dianella, Freo, Kalamunda, Lake Gwelup, Mandurah, Mount Pleasant, Mundaring, Nollamara, Noranda, and York. Support has ranged from walking with churches through ministerial transitions, to engaging in consultations, pastoral care, prayer, preaching and property discussions. Alongside these visits, I have also attended COCWA partner events with Bethanie, Bethesda, ACOM, GMP and CCSRA strengthening relationships that enable us to better serve our churches.

STRATEGIC DIRECTION 2026—2030

A second key focus for the board this year (after the appointment of a new EM) has been the preparation of a new Strategic Priorities Plan for 2026–2030. This plan will guide the next season of our association's mission and builds on the foundations of the previous four strategic priorities. The plan identifies five priorities:

- 1. Unity in Christ
- 2. Church Health & Planting
- 3. Leadership Development & Next Generations
- 4. Governance & Safeguarding
- 5. Resourcing & Operations

While each of these is vital, I am especially drawn to highlight *Unity in Christ* as our central priority. In an increasingly complex environment—socially, politically, and organisationally—it is Christ himself who holds us together as an interdependent family of diverse churches (Col 1:17-18). From this unity flows our ability to collaborate, grow healthy leaders, plant and revitalise congregations, and steward governance and operations with excellence.

GOVERNANCE AND OPERATIONS

Significant steps have been taken this year to strengthen governance and operational support:

- Preparing and submitting our application to be a Christian Ministry Advancement (CMA) certified board.
- As our Operations Manager and Secretary of the Board, Lauren enrolled in and has made progress in her Diploma of Governance and Josh Edwards graduated the CMA board intern program.
- Trialing software systems to help churches manage compliance better.
- Ongoing Governance Excellence training and Chairpersons' Network gatherings.
- Continued administration of grants, loans, and compliance services that directly resource local churches.

Our operations team has been steadfast, providing essential services in insurance, bookkeeping, accreditation, compliance, and communications. I am grateful for their patience and wisdom as I have learned the ropes.

REFLECTION

As I reflect on this first season, I am drawn again to the Emmaus Road story in Luke 24. The disciples' expectations of the Kingdom were challenged and reshaped as the risen Christ walked with them, opened the Scriptures, and made himself known in the breaking of bread.

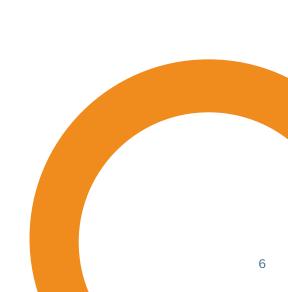
I believe this for us. Our strategies and hopes for ministry can so easily be shaped by cultural, denominational and even political assumptions. Yet the resurrection of Jesus calls us to lift our eyes in *resurrection-shaped hope*—a hope that is neither naive nor triumphalistic, but grounded in the presence of the risen Christ, who, by his Spirit is leading his people to serve God's purposes in our generation.

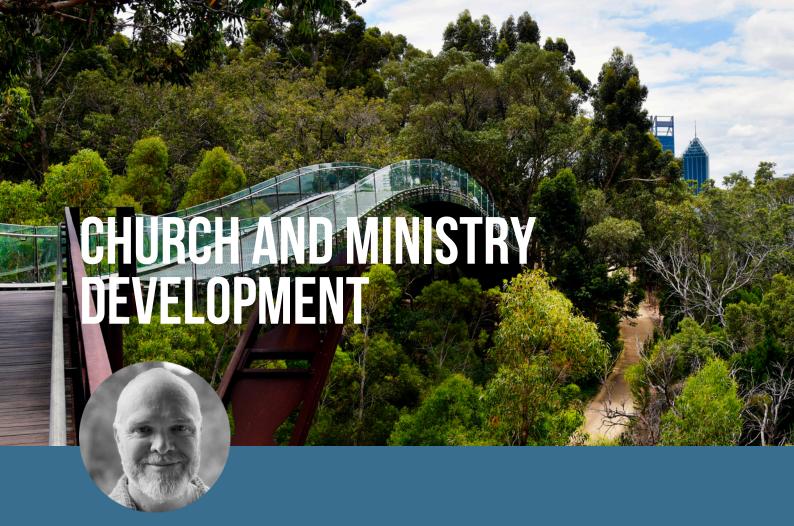

This year has been full of opportunities to walk alongside churches, pastors, and chaplains across WA. My main areas of focus:

- Supporting churches, ministers, and chaplains
- Encouraging and resourcing church planting
- Building collaboration across our association
- Overseeing accreditation and re-accreditation for ministers and chaplains

HIGHLIGHTS FROM THE YEAR

- Launch Event An evening for all ministers, chaplains, board members and team members to gather, celebrate, and launch the year ahead.
- Senior Ministers Retreat A great time away for refreshment, connection, and encouragement.
- Connect Retreat Bringing together newly accredited ministers and chaplains to connect with God others and the ethos and history of Churches of Christ.

CHURCH HEALTH

Four churches have been working with Manna Consulting, taking intentional steps toward becoming healthier and more effective in their mission.

Daron Crothers wrapped up his role in church planting and church health after facilitating all of the above funding, alongside the Church Planting and Mobilisation Team. Daron has been integral in the development of a solid foundation and strategy that equips, and funds established churches to multiply and plant churches. A great job and thank you Daron!

Grant Cullen Church Support and Ministers' Wellbeing



This year in the Next Gen Leadership Development space has been one of learning, reflection, and moving forward into the future of how we can continue building this initiative. While much of our work has focused on strengthening the foundations for a more sustainable future to support those in the early stages of ministry, we have also celebrated some significant God moments that we are deeply encouraged by.

EDGE CAMP — GROWING AND MULTIPLYING

For the first time, Edge Camp ran as two separate camps: one for Years 11–12 and another for Years 7–10. This change was driven by both growing numbers and the desire to create intentional spaces for leadership training.

Edge Camp, for those unfamiliar, is a combined youth camp run with various churches across WA. It provides young people with a place to explore faith, build community, and connect with peers from different churches.

A major new feature this year was the launch of Camp+, a leadership pathway for Year 12 students. During their camp, these students were given space to explore their leadership gifts while learning from the leaders around them. When their camp concluded, they transitioned into a junior leadership role for the Years 7–10 camp. This model of *learning*, *watching*, *and then doing* gave them valuable hands-on ministry experience and has laid the groundwork for the next generation of leaders.

STATE YOUTH GAMES — EXPANDING AND STRENGTHENING

State Youth Games (SYG) continues to be one of the largest youth events on the calendar. In 2025, the event grew again, with nearly 1,400 participants and volunteers involved, representing 22 churches from across WA.

This year also brought a key opportunity for growth through an internal audit of risk and safety. We invited:

- Josh Leauanae, Insurance Director for Churches of Christ Insurance, and
- Viliamu (Vili) Leuga, Safe Places and Professional Standards Consultant for Churches of Christ Vic/Tas.

Together, they reviewed both our policies and the on-the-ground running of the event. Their feedback affirmed that SYG is a safe, well-run space for churches to attend, which was incredibly encouraging. We plan to continue inviting Josh and Vili to partner with us in refining policy and procedure into the future.

NEXT GEN FUNDING — SUPPORTING LOCAL CHURCHES

This year, five churches participated in our Next Gen Funding Program, with one scholarship and four grants approved. The participating churches were:

- Cornerstone Church
- Warnbro Community Church
- The Common
- Mundaring Church of Christ
- Maylands Church

Through this program, we are able to support and equip leaders and churches as they invest in the development of young leaders within their communities.

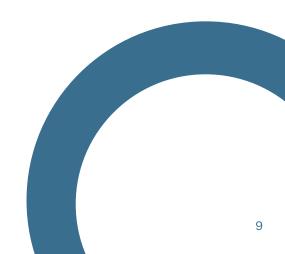
LOOKING AHEAD TO 2026

OPERATIONS

Despite 2025 being a year of significant change for our team, I am really proud of how everybody has adapted and grown throughout the year. We have welcomed two new team members this year with Lauren Harvey joining our bookkeeping team and Steve as our incoming Executive Minister. Both Lauren and Steve have seamlessly become part of the CoCWA team, and we are thankful for the experience and vibrancy they bring. Paddy has gone to two days a week to take a pastoral care role in his church, and Jo, Grant and Jeremy have all added an extra day to their work week to increase our team's capacity to support the association.

Sienny, Paddy and Lauren, have continued to offer bookkeeping services to 13 of our churches and enjoy all the interactions they get to have with people on the ground in our local churches. Each of our churches has its own specific context so they are kept busy with all the bookkeeping nuances that they encounter. Tracey and Jo continue to be the friendly faces behind our administration, playing vital roles in keeping us ticking along and engaging with all our churches. Tracey continues to curate our On Mission Weekly, which I know many of you read and keep up with. Jo has once again been the consistent voice on the end of your insurance enquiries and helped to coordinate the three-yearly property valuations that have recently taken place in September.

Our church support team were busy this year travelling far and wide to meet with as many ministers and chaplains as they can to offer support and encouragement for the many ministry challenges that you are all familiar with. I must give my thanks once again to Richard Affleck, Trevor Harvey and Harvey Collins for their involvement in our Governance Excellence Team. In partnership we have been able to continue with the 'Chairpersons Network' meeting together twice this year and then also heading north with John before his long service leave to provide governance training in Geraldton. We have also offered sponsorships for church board members to attend governance training through the 'Institute of Community Directors' and have strengthened our relationship with Christian Ministry Advancement (CMA) with myself, Sienny (CoCWA Finance Manager), Rod (CoCWA Board Chair), Kayleigh (CoCWA Vice Chair) and Josh (CoCWA CMA Board Intern) attending this year's CMA conference in Melbourne and also by contributing to the development of the church specific board member training they are currently developing, which will hopefully be ready for 2026.

In our Church Safe support, we have continued to be able to respond to various church needs as they have arisen as well as offering subsidised online 'ChildSafe Australia' training for Churches of Christ volunteers, with many churches and volunteers taking us up on this offer. In response to new Work Health and Safety legislation we have been able to partner with 'Empatia' and have created the opportunity for our churches to take part in an assessment survey for their staff and volunteers (this is currently underway for those churches who chose to be part of this) and then followed up with training workshops for church leadership, and an awareness session for church Boards, both of which will take place later in November.

Recently we have also begun working with Bastion System's to create a Churches of Christ WA specific platform to assist churches with their safety and compliance needs. We are currently piloting this software with a few of our churches to road test it ahead of the launch in early 2026. This will allow churches for a small opt in fee to be able to manage and review their compliance needs across property and people. We are thankful for our brothers and sisters in Churches of Christ Vic/Tas for introducing us to the team at Bastion who are passionate about easing the compliance and safety burden that churches feel.

Thank you for the opportunity to serve you again this past year, I am incredibly grateful for the many wonderful men and women leading our churches and count it a privilege to be able to support and offer resources to you.

GLOBAL MISSION PARTNERS (GMP)

Global Mission Partners wishes to express our sincerest gratitude to all the churches and members of COCWA who have prayed, encouraged, visited and financially supported our partners overseas and within Australia this past year.

16 COCWA churches and 145 households from across the state contributed to the work of Global Mission Partners this last year. This support means we are able to advance our mission through our three program areas - the gospel through International Church Partnerships (ICP), our Christian aid and development work through Churches of Christ Overseas Aid (COCOA) and carry on our support for Indigenous Ministries Australia (IMA).

ICP has helped train and equip 758 leaders across 11 countries which has resulted in 20 new churches and 909 people coming to faith in Jesus, often in very difficult and sometimes persecuted circumstances. This year Global Mission Partners hosted Hery Susanto from CCTSI (one of our ICP partners in Indonesia) who visited VIC and WA and spent time with COCWA leadership and hosting mission workshops at Subi Church. This tour saw over 2,700 people hear about CCTSI's unique leadership training approach, including the audience of Sonshine FM.

Our next Discovery Trip is to Zimbabwe in July 2026 — a place I've seen tremendous church growth and revival, with whole villages coming to faith. Please see our website for details if you'd like to join us.

COCOA partners are inspiring examples of sharing God's love in desperate settings.

- In response to the Vanuatu earthquake, Churches of Christ Vanuatu have mobilised to provide counselling and psychosocial support to those who fear the aftershocks and sleeping inside. Over 1,000 were directly assisted.
- Amidst drought and water shortages in Zimbabwe, Showers of Blessing dug 11 wells (boreholes) this year, providing communities with access to clean water.
- For those seeking generational change through education in South Sudan, Christian Mercy International distributed 90 families with goats (3 each) a sign of prosperity.
- Among low-caste families who pick through rubbish for their survival, Hosanna Ministries in India is providing early education and livelihood skills to break the cycle of poverty.

Although Remy concluded his role with IMA in WA this past year, Global Mission Partners continues to provide support to the Bunbury Aboriginal Christian Fellowship (WA) and also to Dareton Youth and Community Centre (VIC). IMA is developing a new future vision, focused on supporting emerging Indigenous leaders and building positive cross-cultural relations. This past year IMA has hosted 38 people on our cultural immersions (Discovery Trips) and 140 on our Songlines tours. We hope you might join us for one soon.

A significant milestone for Global Mission Partners this year has been the introduction of our new brand and website. This is a new look for a new season of mission.

AUSTRALIAN COLLEGE OF MINISTRIES (ACOM)

The Australian College of Ministries exists to equip students to thrive as Disciples of Christ in a rapidly changing world.

We are a college of ministry, specialising in equipping God's people wherever they work, minister and live—in the church, workplace and community. This is our heart as we partner with churches and organisations across the country to help prepare people for Kingdom service and to see God's Church flourish.

ACOM was first established in 1998 with the merger of our NSW and Qld Churches of Christ Theological Colleges. The West Australian Hub was established at South Perth Church of Christ under the leadership of David Stanford, and we have had a presence in WA ever since.

In 2023, ACOM and Stirling College combined to form 'One National College' for Churches of Christ in Australia, paving the way for national ownership of the College and for all State Conferences to contribute to the strategic direction of the College as together we prepare people for Ministry in our churches and ministries around the country and beyond.

Personally, it is my privilege to have worked for ACOM for 20 years and to have led the College for the past five years. Having trained at the NSW College in Carlingford, my first involvement with teaching Youth Ministry classes at the College began when I was Associate Minister at Thornlie Church of Christ, where I served for seven years. I also had the privilege of serving as the COCWA Youth Vision Ministry Coach.

ACOM is known for our focus on spiritual formation, practical ministry training, face-to-face facilitations, and mission, all centred on helping local churches to thrive with well-equipped, Kingdom-ready servants. At ACOM, we remain committed to bringing the academy to the church, training men & women where they are and at a pace that suits them, so that our churches might thrive! I am pleased to share that our new

Church Planting awards at Diploma, Bachelor, and Masters levels are ready to launch in February 2026. Additionally, we've relaunched our Local Church 1-Year Internship Program. We invite inquiries about these opportunities, along with all other ACOM programs.

I'm also pleased to report that in 2024, we enrolled 208 students into new awards. This represents another significant enrolment of students into new awards and a continued positive sign for future growth and sustainability. We also graduated 175 students in 2024, 42 of whom were from Churches of Christ. We particularly congratulate the following WA CofC graduates.

The Bethanie Mission: To demonstrate the love of God by positively changing the way Australians experience ageing – every customer, every family, every community, every day.

The relationship between Bethanie and COCWA remains a cornerstone of our shared mission to serve older Australians with compassion and purpose. SPORTS MINISTRY (CCSRA)

The past year has been a vibrant period for Churches of Christ Sports Ministry, marked by significant growth in vision, community engagement, competition, and new opportunities. NOTES TO THE FINANCIAL STATEMENTS

Churches of Christ in Western Australia Inc For the year ended 30 June 2025

1. Summary of Significant Accounting Policies

The financial report has been drawn up as a special purpose financial report for the purpose of fulfilling the requirements of Churches of Christ in Western Australia Inc, Division 60 of the Australian Charities and Not-for-profits Commission Act 2012 and the WA Associations Incorporation Act 2015. This report provides members with information about the Church as an economic entity which is useful for making and evaluating decisions about the allocation of scarce resources.

The financial report has been prepared on the accruals basis of accounting as defined in AASB 108 Accounting Policies, using the historical cost convention and going concern assumption. Except where stated, it does not take into account changing money values or current valuations of non-current assets. Except where stated, the accounting policies have been consistently applied.

The financial report has been prepared in accordance with the provisions of the Constitution.

The Council have determined that the Churches of Christ in Western Australia Inc is not a reporting entity as defined in the Statement of Accounting Concept 1 "Definition of the Reporting Entity" and therefore as a minimum apply the following accounting standards to the extent that they are relevant:

AASB 101 Presentation of Financial Statements

AASB 107 Statement of Cash Flows

AASB 108 Accounting Policies, Changes in Accounting Estimates and Errors

AASB 124 Related Party Disclosures

AASB 1048 Interpretation of Standards

AASB 1054 Australian Additional Disclosures.

(a) Income Tax

Churches of Christ in Western Australia Inc is exempt from payment of income tax under the item 1.2 of section 50.5 of the Income Assessment Act 1997.

(b) Property, Plant and Equipment (PPE)

Freehold Land and Buildings are shown on the Balance Sheet at revalued cost. Property Improvements are carried at cost. The depreciable amount of all Plant and Equipment is depreciated over the useful lives of the assets to the association commencing from the time the asset is held ready for use.

Plant and Equipment is measured at cost less, where applicable, accumulated depreciation and any impairment losses.

(c) Depreciation

The depreciable amount of property, plant and equipment (excluding freehold land) is depreciated on a straight-line basis. Depreciation commences from the time the asset is available for its intended use.

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at the end of each reporting period. An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

(d) Employee Benefits

A liability for long service leave is recognised, and is measured as the present value of expected future payments to be made in respect of services provided by the employee up to the reporting date.

(e) Provisions

Provisions are recognised when the entity has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured.

Provisions are measured using the best estimate of the amounts required to settle the obligation at the end of the reporting period.

(f) Cash on Hand

Cash on hand includes cash on hand, deposits held at call with banks, and other short-term highly liquid investments with original maturities of three months or less.

(g) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO).

Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the balance sheet.

The deed includes restrictive covenants that impose specific conditions on the recipient's use and disposition of the land. These conditions ensure that the land continues to be used in alignment with COCWA's mission and objectives.

In accordance with the principle of substance over form outlined in AASB 116 and AASB 10, management has assessed that COCWA retains control and beneficial interest over the asset. Consequently, despite legal title being transferred, the land continues to be recognized on the statement of financial position. The recognition reflects management's judgment that risks and rewards associated with the asset remain largely with COCWA.
