You may choose only the items you desire. If you are charged for items you did not specifically request, an explanation will be provided on the written memorandum. Please note that you may be charged for items such as cemetery fees, flowers and newspaper obituaries.

PAYMENT POLICY

Payment of the total funeral contract is expected before services are rendered.

Payments may be made in cash, check, debit or credit card (MasterCard, Visa and American Express). The Service and Merchandise totals may be paid by verifiable, assignable insurance or a Pre-Need Funeral Policy. Questions regarding our Payment Policy may be directed to the Office Manager or a Funeral Director.

Funeral Selection and Financial Policy

Funeral service costs are itemized. You may select or reject various items, all of which will be explained to you prior to making any selections. We want you to select the type of service and burial you prefer, at a cost you can afford. **Your itemized Funeral Purchase Agreement will be reviewed with you, and one or more responsible parties will be asked to sign the acceptance agreement to pay for services.** You will be provided with a copy of the completed financial agreement. In order to assure that the quality of service remains at the level our patrons have come to expect, we ask your cooperation with the following financial arrangements:

- Payment for services is due in full at time the arrangements are made or any time prior to the service date. We accept, cash, check, MasterCard, Visa and American Express for payment. If payment is made by credit card there will be a 4% Processing fee added to the contract.
- We accept an assignment of **confirmed life insurance proceeds** (policy must have been in force for over two years). Funeral contracts being secured financially through insurance proceeds; there will be a 4% fee of the contract total or for the insurance face amount, depending on which one is less. Insurance companies that do not accept insurance assignments from a J. E. Keever Mortuary, Inc. will not be accepted as a form of payment.
- **If your funeral contract exceeds 30 days of not being paid in full from the time your purchase agreement is signed; a late charge at the rate of 1.5% per month, 18% annually, will be applied.**

Death Certificates

J. E. Keever Mortuary, Inc. processes the death certificate for each family. The certified copies of the death certificate are usually available to the family within ten to fifteen working days. This process can be delayed depending on the availability of the physician. If death occurs outside of Ellis County, this process may be delayed up to one month or longer. In certain circumstances when it is determined that the Medical Examiner is the one to sign the death certificate, and the cause of death cannot be immediately determined, the certificate is placed in pending status. While in the pending status, the death certificate **will not** be certified and could take as long as three months for the cause of death to be determined by the Medical Examiner. **Upon receipt of the certified copies of the death certificate, you will be contacted by our business office.**

Cash Advance Items

In arranging a funeral there may be payments to other parties such as the cemetery service for the opening and closing of the grave, cemetery fees, newspapers, clergy, musicians, etc. which will need to be made. J. E. Keever Mortuary, Inc. will be pleased to make these payments, which are referred to as cash advances, on your behalf. Some of these, such as clergy honorarium, are gifts and are subject to your discretion. These amounts will be itemized on your Funeral Purchase Agreement and **must be paid at the time of arrangements.**

Policy for Handling Unembalmed Bodies

There are no laws requiring that a body should be embalmed. You may select a service such as direct cremation or immediate burial which does not require embalming if that is your wish. J. E. Keever Mortuary, Inc. reserves the right to decline to conduct a service for a deceased person who has not been embalmed if the service is to be beyond 24 hours from the time of death. For embalming to be the most beneficial, a decision on whether or not to embalm should be made as soon as possible. As a general policy, J. E. Keever Mortuary, Inc. shall permit **only the deceased's immediate family** to view an unembalmed body. This viewing shall be limited to a brief period not to exceed one hour. **For safety reasons our policy is NOT to open casket at the cemetery.** When selecting burial clothing for your loved one, bear in mind that we **will not** undress the body to return clothing to the family. We consider this disrespectful, undignified and unethical.

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our services and overhead. If legal or other requirements mean you must buy any item you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services.

Basic Services of Funeral Director and Staff: **\$2195.00**

This fee is for basic services and "overhead" which will be added to the total cost of the funeral arrangements. (It is already included in our charges for Direct Cremation, Immediate Burials and forwarding / receiving remains.)

This fee includes:

- *J. E. Keever Mortuary, Inc. personnel available 24 hours a day, 365 days a year to respond to the initial call.*
- *Arrangement conference.*
- *Coordination of service plans with the cemetery, crematory and/or other parties involved in the final disposition of the deceased.*
- *Coordination of service plans with members of the clergy, musicians and any other eulogists involved in the funeral service of the deceased.*
- *Clerical assistance in the completion of various forms associated with the funeral, including, but not limited to Social Security Statement of Death, and Veteran's Administration benefits.*
- *Securing and recording the Death Certificate and disposition permit(s) with the appropriate agencies.*
- *"Overhead" items such as facility use, equipment and inventory costs, taxes, utilities and insurance, administration expenses and governmental compliance costs.*

Embalming **\$995.00**

- ***Embalming is NOT REQUIRED by Federal Law.*** *Embalming may be necessary, however, if you select certain funeral arrangements such as a funeral with a public viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as Direct Cremation or Immediate Burial.*

We are pleased to provide services to produce a (1) Memorial DVD for your family with a full service at no additional charge. For memorial services handled outside of the funeral home there will be a charge of **\$125.00** for memorial videos with one copy, additional copies will be the same charge as for full service.

The video can consist of 25-60 pictures with a **Maximum of 60 photos**. They can be brought to us either by hard copy, picture CD or memory stick (flash drive).

If hard copy pictures are provided we can scan anything from a small wallet picture to 8x10 (some 11x14's can be scanned if they have empty space on the sides). We ask that all pictures be removed from frames and or albums. We will not be held responsible for damage to frames or albums. We will return all photos to the family at the conclusion of service.

We ask that photos be brought for scanning or downloading by 10 a.m. THE DAY PRIOR to visitation or service.

If your family would wish to purchase a copy of the DVD we can make them for an additional charge of \$35.00 per video. Our videos are copy protected and if you try to copy them it may cause damage to the original DVD or video equipment. If you require your DVD to be mailed, we do ask you include an additional \$10.00 for handling fees.
