Owner grants this Authorization for Shop to repair and perform Services upon Vehicle for the above Job(s). Owner or Agent has authority or sufficient interest in Vehicle to freely and intelligently bind all Vehicle owners for full payment of Services and hereby does so.

If present, Owner authorizes all Services at the price listed on an attached itemized appraisal, and may additionally be asked to authorize, whether verbally or in writing, repairs discovered later at a revised price. Owner won't transfer any claim against Shop, and shall give Shop the opportunity to resolve a dispute between the parties prior to any public review or legal action.

Shop is authorized to operate/move/access Vehicle, its contents and all data for any purpose related to Services or Owner and is not responsible for damage or sharing of the same. Owner has a right to receive or inspect replaced parts upon completion by electing so in writing within 24 hours of delivering this Authorization.

Title to Vehicle shall not transfer until Shop is fully paid. Owner's responsibility to pay includes attorney's fees, collection, and court costs necessary to defend Shop's legal rights. Shop may require Owner to assist in collecting on invoice and will reimburse reasonable expenses.

Vehicle cannot be returned to pre-accident condition without use of OEM inspections, procedures, and parts. Insurers may dictate the use of certain non-OEM parts, but Owner is responsible for any delay and costs if Shop determines said part(s) cannot be used safely. Shop solely determines safety decisions and not any document prepared by or for an insurer.

Owner hereby waives the issue of venue for enforcement of this Authorization. By receiving this Authorization Shop forgoes other opportunities and is entitled to full costs and charges of Services expected to be paid in the performance of this Authorization, including where Vehicle is deemed a *total loss*, together with interest from the date of any breach until paid.

Services include disassembly, preparation, diagnosis/testing, photographing, documenting, research, analysis, administrative fees, costs of and related to parts, labor, taxes, cleanup and disposal of hazardous material, sublet costs (with Shop mark-up), daily storage, and all other activities related to the Job(s) for Vehicle repair. Owner has reviewed and accepts Services as commercially reasonable when performed by Shop, to include estimate/diagnosis charges and daily storing charges.

The parties agree that this Authorization: (1) consists entirely of and is governed by these three pages; (2) attaches to Vehicle and is binding upon Owner and all successors in interest; (3) can only be modified in writing signed by Owner and Shop; and (4) has been delivered to Owner, who may request additional copies from Shop as needed.

Replacement transportation is the responsibility of Owner; delays in authorizations or insurer actions may incur additional fees and affect the timeline for Services beyond the delay. A party may end repairs in this Authorization by providing the other written notice, while all remaining provisions stay in effect. In no event will the Shop's liability for Services exceed the total amount paid to Shop under this Authorization.

Should any clause of this Authorization be found unenforceable, that clause shall be narrowly stricken to give full force and effect to all remaining parts. Shop's final invoice must be paid in full, including the costs of any sublet services, prior to release of statutory lien. Shop may charge storage for an unlimited number of days until invoice is paid in full.

Owner Declaration: In addition to the above authorizations and understandings which I lawfully undertake, I understand that I have the right to know before authorizing any repairs what the repairs to my Vehicle will be and what their cost will be. Shop need not obtain approval from me for repairs or inform me prior to performing repairs what the repairs are or their cost, if the total amount of repairs does not exceed the Pre-Approved Total Cost below, if any.

Services may be payable under one or more insurance claims, I authorize you (Shop) and **direct any relevant first- or third-party insurer** as follows:

Direction to Pay: Time is of the essence and insurer shall: tender all payments for Services by check or cash directly to Shop within five days of insurer’s original appraisal or within three days of insurer’s prompt evaluation of any supplement request; notify Shop of any attempt to rescind this direction; and name the Shop on each payment for property damage. I hereby grant Shop a limited power of attorney to endorse claim’s checks for payment, as needed.

I **assign to Shop** all rights: against any responsible party/insurer (first- or third-party); under an insurance claim; and to commence action for legal violations and payment of Services including Services not listed in an initial appraisal. **Insurer shall release to Shop** all information regarding any related claim under any related policy, including claim numbers, policy language, coverage limits, applicable deductibles, liability determination, pictures, appraisals, total loss report(s), market valuations, and any other related information.

Services include the below rates which: I accept as reasonable; may be flat rate, estimated, or actual; are not exhaustive; and may reasonably increase from time to time as Shop’s costs of doing business increase.
