# **MEET THE SPEAKERS**

JOHN T HILL, a native of Raleigh, North Carolina, is a licensed embalmer and funeral director in the states of North Carolina, South Carolina, Texas, and Washington D.C. He has earned many other titles in the Funeral profession: Restorative Arts Specialist, Certified Funeral Service Practitioner (CFSP), Member of the British Institute of Embalming (MBIE), Funeral Service Education Instructor, Chaplain, Celebrant, and Certified Crematory Operator (CCO).

He works full time at James Funeral Home and Northlake Memorial Gardens in Huntersville, North Carolina. He owns Hill Mortuary Service, a trade embalming and restorative arts service to funeral homes and has helped over 30 firms. Whenever schedule allows, John also is a trade embalmer for Rouse Mortuary Service in Greenville, North Carolina, which is the largest mortuary service in the state.

In October of 2020, John became a Funeral Service Education Instructor at his alma mater, Fayetteville Technical Community College in Fayetteville, North Carolina teaching the Embalming courses with labs and Restorative Arts courses with labs. In September of 2022, he also became an instructor for Gupton-Jones College of Funeral Service teaching embalming and other funeral science courses. He is also a presenter at funeral service seminars in continuing education courses.

Specialist by furthering his education on
embalming and restorative arts in Advance Post
Mortem Reconstructive Surgery at Fountain
National Academy of Professional Embalming
Skills in Springfield, Missouri under Vernie

R. Fountain. He has also received continued education in Anatomical Preservation and Dissection Theory at Fayetteville Technical Community College in Fayetteville, North Carolina and Experience Anatomy in Charlotte, North Carolina.

### **RUSSELL UPTEGROVE.** M.D. Coroner

Dr. Uptegrove started working with the Coroner's Office April 1, 2004. He assisted Dr. Young until Dr. Young's retirement in April 2007 at which time he was appointed as County Coroner.

Dr. Uptegrove received his undergraduate degree from Clemson University and his medical degree from the Medical University of South Carolina. He completed a residency in Anatomic and Clinical Pathology at the Medical University. He completed a fellowship in Forensic Pathology at the Charleston County Medical Examiner's Office.

He has been involved with death investigation since 1992 and is a Forensic Pathologist for the Montgomery County Coroner's Office. He is a guest lecturer at the Ohio Peace Officers Training Academy in London, Ohio and Clinical Instructor for Wright State University School of Medicine. He is also a member of the Ohio State Coroner's Association, American Academy of Forensic Sciences and National Association of Medical Examiners.
