Mike Squires' career in funeral service has spanned five decades, from the earliest days at a funeral home in rural South Carolina to managing South Carolina's state association for the past 18 years.

In between, Squires served families at McEwen Funeral Service in Charlotte – one of the largest firms in North Carolina – and was vice president and general manager of Wilson Funeral Service, also in Charlotte.

In 2013 Mike began publishing Southern Calls, A Funeral Director's Perspective, with a circulation of 6,000.

A licensed funeral director, Squires resides in Mt. Pleasant, South Carolina with his wife Gloria.

#### Jon W. Rettig, Sr.

Jon was born in Defiance, Ohio and is a 1973 graduate of Holgate High School, Holgate, Ohio. He then attended Lakeland College, Sheboygan, Wisconsin, majoring in business. He is a 1976 graduate of the Cincinnati College of Mortuary Science, Cincinnati, Ohio and earned certification to enucleate donor eyes in 1979 from the University Of Pittsburgh School Of Medicine.

An Ohio licensed funeral director and embalmer since 1977, Jon is President of Family Care Services, Inc. which owns and operates the Woods-Rettig Funeral Home, Leetonia, OH, Warrick-Kummer-Rettig Funeral Home, Columbiana, OH, Van Dyke-Swaney-Rettig Funeral Home, East Palestine, OH, and Family Care Cremation Services, Columbiana, OH. In 2014 he was certified as a Certified Crematory Operator.

He is a member of St. Paul's Lutheran Church, Leetonia, OH and Grace Lutheran Church, East Palestine, OH where he served on both church councils. He is a member and Past President of the Ohio Funeral Directors Association and served on most committees of the association. He is also a member of the National Funeral Directors Association and the Cremation Association of North America. Locally he is a member and past president of the Columbiana Rotary Club and was active in the Rotary Youth Exchange Program for several years, having his family host nine exchange students over the years. For nine years he served as a board member of the Salem Regional Medical Center, Salem, OH where he served on the finance committee, the quality improvement committee,

and the Ad Hoc Information Technology Committee. He is also a charter member and past chairman of the Charitable Foundation of the Salem Regional Medical Center, Salem, OH and has served several terms on the Columbiana County Planning Commission.

He was appointed to the Ohio Board of Embalmers and Funeral Directors in April 2016 by former Governor Kasich and reappointed to the board by Governor DeWine in July 2020. He served as president of the board from July 2016 until July 2019 and is currently serving as chairman of the State of Ohio Crematory Review Board. In February 2020 Rettig was elected to the board of the International Conference of Funeral Examining Boards and was elected Secretary-Treasurer in February 2021. Jon is married to Ellen Mraz Rettig, a licensed funeral director and they make their home in Columbiana, OH. They have four grown children and six grandchildren.

**Adam Dwyer** is a licensed FD and Embalmer. Dwyer earned his Bachelor of Mortuary Science in 2001. Dwyer worked in Cincinnati at Imwalle FH. Eventually he went to work at Greater Cincinnati Trade and Livery where he spent the next 16 Years. There he honed his embalming skills making him one of S West Ohio's most sought after Embalmers. Dwyer opened Dwyer Professional services in 2012. He expanded his services from just embalming to include livery work and funeral directing. Adam most recently acquired Storer Mortuary Services.
