Since 1987 the Henderson County HELP Center has been dedicated to supporting families and children in Henderson County. Over the years the Centers teams have created and sustained programs which promote self-sufficiency and well-being to thousands of families and children across Henderson County.

Under the HELP Center's umbrella, the center created Maggie's House Child Advocacy Center to provide supportive services to children and families who deal with issues of horrific child abuse and neglect. Maggie's House opened in 2000 to support Hope, Healing and Justice for the most vulnerable and unheard victims of abuse and neglect. Within the walls of support services for these smallest victims, Maggie's House provides the initial Forensic Interview of the alleged abuse, counseling services for these smallest victims and non-offending family members, medical services and long-term case management. All of Maggie's Houses services are free to the victims and their families. Since its inception Maggie's House has supported **12,188** child victims of abuse with healing and restoration. Last year Maggie's House supported **471** children in Henderson County who suffered at the hands of an abuser and the number is growing for 2024.
