Required Professional Fees

Required professional consultation with licensed personnel, which may include but is not limited to: expert advice on options to meet your needs including essential services relating to disposition, drafting notices, planning and scheduling of services, and advising regarding possible government benefits. Basic professional fees are payable whenever we provide services to you.

Co-ordinating Rites and Ceremonies

Co-ordination of all rites and ceremonies, including services and supplies provided by us, as well as those provided by third party suppliers, such as death notice, church, clergy, coroner.

Documentation – Permits, Forms, etc.

Completion and filing of all documents necessary to carry out the services and supplies requested including but not limited to: death registration, burial permit, coroner's certificate, and documentation necessary for shipping. We provide you with 10 proofs of death for estate settlement purposes. Sometimes a provincial death certificate will be necessary and is available from the Office of the Registrar General.

Transport Remains (within 35 km)

Transportation of the remains from place of death to Funeral Home.

An additional fee of \$100 for handling and transporting deceased from a residence or if deceased weighs over 175lbs.

Required Preparation of Deceased

*P*reparation of the deceased for placement into the casket or cremation container, including bathing, dressing and the setting of facial features for identification or viewing purposes without embalming.

Embalming of Remains

Embalming is the process of replacing blood and bodily fluids with a chemical preservative for the purpose of sanitation, restoration and temporary preservation. Embalming is not a legal requirement, however it is highly recommended when a casket is present for a visitation or funeral service. The licensed funeral director will make a recommendation based on the condition of the deceased as to the expected service needed.

* Note... even though embalming is not a legal requirement, other locations (provinces or countries) may require embalming if the deceased is coming from their location to ours or vice versa. Also, we reserve the right to remove the deceased from the visitation site and/or the ceremony site if problems occur before final disposition takes place.



Subsequent Transport of Remains – Additional This is a secondary transportation charge applied for the use of our general duty vehicle, such as transfer remains to another location for visitation, or to transfer remains from another location to our funeral home for visitation prior to the ceremony.	\$100.00
Extended Shelter of Remains: This is a fee for the storage of human remains in a climate-controlled holding facility. (\$95.00 per day after exceeding 48 hours)	\$95.00
Removal of Pacemaker or Other Implant: The removal of a pacemaker or implant will be carried out by a licensed funeral director.	\$125.00
Environmental Service Surcharge: A charge for biohazard materials and disposal costs will be made in some circumstances and our licensed staff will discuss this issue with you.	\$50.00
Beverage and Plate Service: This fee is applied when the funeral home provides coffee, tea, milk, cream, sugar, water and juice/Plates and napkins (per person)	\$2.00

Disbursements

Payment terms: (on all at-need funeral arrangements)

A deposit of 50% is due upon signing of the contract. We ask that payment in full be finalized within 7 business days. For unpaid accounts, interest will be charged at a rate of 2% per month to a maximum of 24% per annum.

There will be a charge of \$25.00 for any non-sufficient funds (NSF) cheques returned by the bank. Any costs of collection shall be the responsibility of the Purchaser.

Funding: (on pre-paid funeral contracts only)

For your convenience, we offer two funding options.

Insurance: You may purchase an insurance contract where the proceeds of that contract will be used to pay for services or supplies at the time they are delivered, or the contract is cancelled.

Trust: You may pay the money directly to us and we will place it in trust, where it will accrue interest until the contract is fulfilled (when the services and supplies are delivered) or the contract is cancelled.

Social Assistance

The Niagara region offers coverage for funeral services on behalf of residents whose estates cannot otherwise cover the cost. Should this be the case we can help guide the family in the right direction. This must be brought up before the contract is signed or any steps are taken.

We request payment within one week from the date the contract was signed. If this is an issue, talk to us to see how we can work with you.

After 30 days, a 2% interest charge will accrue per month to a maximum of 24% per annum.
