Prices effective **August 1, 2025** and are subject to change without notice. The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected. This list does not include prices for certain items you may ask us to buy for you, such as cemetery services, flowers and newspaper notices. The prices for those items will be shown on your bill or the statement of funeral goods and services selected.

Prior to drafting any contract for goods or services, the responsible party or the decedent's survivor who is handling the funeral arrangements is entitled to receive a copy of any preneed agreement in the possession of the funeral establishment that has been signed and paid for, in full or in part, by or on behalf of the decedent.

# PROFESSIONAL SERVICES

## BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF \$1,995

Our charge includes consultation with the family or responsible party; staff and facilities to respond to initial requests for service; coordinating service plans with cemetery; securing official documents and necessary registrations and sheltering of the deceased. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

### EMBALMING \$695

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

Our charge for this service includes basic services of funeral director and staff, transfer of remains to funeral home, embalming, van/utility vehicle for transportation to Ontario Airport. This charge does not include viewing, ceremony or airline shipping charges.

## **RECEIVING REMAINS FROM ANOTHER FUNERAL HOME** \$1,995.00

Our charge for this service includes basic services of funeral director and staff, transfer of remains to the funeral home from Ontario Airport, and van/utility vehicle for local transportation to local cemetery or crematory. This charge does not include visitation, rites or ceremonies.

## **IMMEDIATE BURIALS (\$1,995.00 TO \$3,290.00)**

Our charge for an immediate burial without any attendant rites or ceremonies includes basic services of funeral director and staff, transfer of remains to funeral home, vehicle for transportation to place of disposition and care of remains. Remains will be buried at the convenience of the cemetery, vault company and funeral home.

Immediate burial with container provided by family.....	\$1,995

## **DIRECT CREMATION (\$1,895 TO \$2,090)**

Our charge for direct cremation without any attendant rites or ceremonies includes basic services of funeral director and staffs, local transfer by one attendant of remains to funeral home, care of remains, transfer to crematory and crematory fee. State and local laws do not require a casket for cremation. If you want to arrange a direct cremation, you can use an alternate container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are made of cardboard. State and county filing fees, death certificates, permits and taxes not included.

## **PAYMENT POLICY**

Our funeral home is a small business and like many others in our community, out of necessity, we operate on a cash basis, relying upon the families we serve for prompt payment. We do not have sufficient financial resources to extend credit over a period of months or years, nor does law allow us to fulfill the functions of a bank or other lending institution. Therefore, payment is expected 24 Hours prior to the rendering of Service. If payment in full is not completed at time designated, services will be postponed and rescheduled once complete payment has been made.

We encourage your frank discussion of these matters with your funeral director, and we will attempt to assist you in any way possible.

## **FLORAL PAYMENT POLICY**

We include floral credit to some of our funeral packages in order to provide more care to our families we serve. Foothill Funeral has partnered with Andrea Batista at Pushing Up Daisies because of the extensive funeral experience she holds and the understanding of details, love and care a floral piece should have for one's last milestone. All floral sales will be invoiced separately and payments must be made to our florist in order to secure floral orders for the day of service. Pushing Up Daisies accepts the following forms of payment, Venmo, Zelle, credit card and checks written to Andrea Batista.

## **PAYMENT OPTIONS**

- Payment with cash or check.
- Payment with an approved Credit Card.
- Pre-paid funeral arrangements with Foothill Funeral & Cremation, subject to verification the policy is valid.
- Assignment of Insurance Proceeds (Financed by American Funeral Financial). Assignment of non-contestable insurance policies can be financed through certain institutions as long as a known cause of death is listed on the Death Certificate. The Financing Company usually charges a fee of up to 5% of amount assigned. As an accommodation to the family, the Financing Company will make the funeral/cemetery expense payment directly to the mortuary usually within 7 to 10 working days after all information is verified and received.
