IMPORTANT NEWS: Five (5) Public Retirees (including four RPEA members), together with the AK AFL-CIO and NEA Alaska, have filed suit against the State of Alaska because Governor Dunleavy has failed to follow the statute and has not made timely appointments to fill two vacancies on the Alaska Retirement Management Board, vacancies that are to be filled by persons in the PERS and TRS retirement systems.
