### **Legislative Update**

The Alaska Legislature is in the throes of working to close out its second session!

As you know, the RPEA is following a number of bills of interest to public retirees. You can track the bills the RPEA's Legislative Information Committee is following by reviewing the spreadsheet compiled weekly by the Committee Director Courtney King.

You will find a link to that spreadsheet on the RPEA's website under the *Standing Committee's link to the Legislative Committee in the Members' Only area of our website.*

The **Alaska Legislature's** first end-of-session deadline is Sunday, **April 19**, 2026, the 90<sup>th</sup> day of the second session. If the Legislature does not adjourn on or before the 90<sup>th</sup> day, the session can be extended until the 121<sup>st</sup> day, which is Wednesday, **May 20**, 2026.

### Upcoming Dates of Interest:

**The State of Alaska's August Primary is August 18, 2026, and the General Election will be held on November 3, 2026.** These are important elections, as we are electing one of our two U.S. Senators, our U.S. Representative, a new Governor, all State House members, and ten of the twenty State Senators.

**If you are an Alaska resident**, you must be registered to vote at least 30 days before the date of either election, i.e., on or before **July 19<sup>th</sup> for the primary** and **October 4<sup>th</sup> for the general**.
