The TaskForce operates Homeless Outreach Teams delivering outreach services, housing case management, and mental health care, while also coordinating referrals and linkages to housing, shelter, legal aid, primary healthcare, behavioral healthcare, and basic needs such as hygiene products, bus passes, and clothing. In addition, the organization serves as a regional Continuum of Care lead, supporting system coordination, planning, and capacity-building efforts to strengthen homeless response systems across multiple jurisdictions.
