**Affidavit Guidance Notes**

*This affidavit must be sworn before a Notary Royal or Justice of the Peace. All blank fields are to be completed. Where two or more options are separated by a (/), the option which applies is to be underlined.*

*Blank fields are to be completed as follows:*

- (i) Insert record holder's father's full name.*
- (ii) Insert record holder's father's address.*
- (iii) Insert country in which record holder's father lives.*
- (iv) Insert record holder's father's occupation. If father is unemployed, simply write **unemployed**.*
- (v) Insert record holder's father's postal address.*
- (vi) Insert record holder's father's name.*
- (vii) Insert record holder's full name.*
- (viii) Insert record holder's place of birth e.g. **Victoria Hospital or Mon Repos**.*
- (ix) Insert district in which record holder was born.*
- (x) Insert record holder's birth date in following format - **3rd April, 2005**.*
- (xi) Insert district in which record holder was born, as is recorded at top of Birth Certificate.*
- (xii) Insert year in which record holder's birth was registered, as appears in upper left-hand corner of Birth Certificate.*
- (xiii) Insert number in register at which record holder's birth is recorded, as appears in column marked "No. of Register" on Birth Certificate.*
- (xiv) Insert page in register at which record holder's birth is recorded, as appears at top of Birth Certificate.*
- (xv) Insert record holder's father's full name.*
- (xvi) Insert record holder's father's address at time of record holder's birth.*
- (xvii) Insert record holder's father's occupation at time of record holder's birth.*
