COMMITTEES OVERVIEW

AWARDS OF EXCELLENCE COMMITTEE	This Committee plans and organizes the annual NAIOP Awards of Excellence. This includes recruiting of nominees, sponsors for the event (past sponsors and new), recruiting attendees as well as arriving early to set up the day of.
DEVELOPING LEADERS COMMITTEE	Members (for NAIOP members 35 years of age and younger) organize and plan social, educational and community service activities throughout South Florida. These events are open to all and are traditionally smaller, intended to develop relationships with seasoned members while forging future business relations.
EVENT REGISTRATION/VOLUNTEER COMMITTEE	The Registration Committee is responsible for attending Chapter's various programs and events by assisting with the registration of event providing name tags, greeting attendees, setting up for the event, and breaking down from the event.
GOLF COMMITTEE	Members organize and plan the annual golf tournament which is in support of a local charity. This includes recruiting players, prizes, site location and sponsors for the event.
MEMBERSHIP COMMITTEE	Members actively seek new members for the local NAIOP Chapter. It also engages with current members to keep them renewing and stay active within the organization. The Committee is also responsible for reaching out to new members who attend Chapter events in order to make them feel welcomed and oriented to Chapter activities.
MIAMI-DADE PLANNING COMMITTEE	Members plan and organize commercial real estate update event highlighting Miami-Dade County and will attend zoom meetings and venue or panelist outreach. Member volunteers work with developers, owners, asset managers and brokers to include properties to be showcased, as well as get sponsors and come up with a theme for the event.
PROGRAM COMMITTEE (please select preferred county)	Members organize overall programs for the local NAIOP SFL Chapter which includes recruiting both speakers and moderators, as well as sponsors and location for the event.
