Boron is essential for translocating sugars throughout the plant and helps strengthen cell walls. Many micronutrients, such as zinc, manganese, iron, and molybdenum are required by plant enzymes to carry out various functions, including photosynthesis and metabolizing nitrogen within the plant.

DIRECTIONS FOR USE:

ALL CROPS: Apply 1 to 2 quarts per acre, with starters and liquid nitrogen applications. Can be foliar applied by itself or with other nutrient products at 1 to 2 quarts per acre.

TURF & ORNAMENTALS: Apply 1 to 3 oz/1000ft². Apply .5 to 1 oz/gal of water in dip or drench applications.

NOTES: Apply with 10 to 20 gallons of water. Can be applied with other Sugar Creek Ag products and most herbicides, pesticides, and fungicides. Can be applied through drip or overhead irrigation. Agitate before use.

We suggest conducting a jar test prior to mixing with other ingredients to establish compatibility. If the solution is left in the spray tank overnight, agitate thoroughly before spraying. To avoid crop damage due to high temperatures, it is suggested to apply early morning or early evening. Product should not be stored where freezing is possible. Product may settle in storage and should be agitated before use.
