Item Description

1 Welcome

John Hubbard (**JH**) opened the meeting and welcomed all those present. He invited Revd. Andrew Micklefield to lead an opening prayer.

JH gave the background to the attendees as to how Resurrection Trading (**RT**) was started by members of St Lawrence Church and explained that the PCC creates a connection between the POTR and **RT** because PCC members are also members of **RT**.

JH invited Eleanor Hill from Alton Sustainable Eating (aka SustainaBites), to speak briefly on their purpose. Eleanor spoke about this new group within ACAN, formed less than 1 year ago: it has the mission to give people a chance to taste plant-based foods and to promote the advantages to diet, health and the environment

2 Chairman's Report

Presentation and adoption of the report and annual accounts. **JH** talked to this, specifically highlighting:

- Natash Perrin's excellent performance as manager from June 2023 and her inclusive style of management
- The volunteer force is 60 strong, divided between shop, workshop and van teams: there have been few leavers during the course of the year
- At the Summer Graden Party long-service awards were presented to John Hubbard, Joyce Willman, Anne Marshall and Gary Phillips
- A work experience programme has been set up with Alton College
- Visual merchandising continues to be improved, including the introduction of a new window 'stage' display area
- There have been major mechanical problems with the van but repairs and use of interim rented vans have been expertly coordinated by Tim Codling
- The workshop team continue to repair and enhance donated furniture and this often requires a balance between spending sufficient vs too much time/resources
- Some items for sale in the shop are for the Monthly Market
- The trustees have approved two additional strap lines: 'Supporting our local community' and 'Reuse, recycle, resurrect!'
- Customers like coming into the shop; they enjoy the friendly reception and the personal touch and so weekly sales are rising: up from £2500 to £2850 in a year. JH thanked the volunteers for this achievement and this was greeted with applause
- In the y/e June 2024, RT allocated £50k in grants. Some of the causes were nominated by volunteers. Funding to POTR saw an increase of 40% to fund the cost of a CYF worker. A two-year funding agreement with CAP began
- June 2024 also saw **RT** reaching the milestone of a total of £100k awarded in grants since it's inception in 2017: this was greeted with applause by the meeting
- This year there is the potential to give a further £100k (£70k, plus £30k unspent). **RT** will improve grant-giving procedure with a new policy and will launch a plan to attract new grant applications
- JH suggested for any questions to be addressed at the end of the meeting

- Robin Lees announced that weekly revenue was currently averaging £3100: this is running at £350 p/w more than last year
- Revd. Andrew Micklefield gave thanks to JH for all that he has been doing 'behind the scenes' and acknowledged and gave thanks for the speedy journey from a startup to the major success that RT now is
- Lisa Hillan relayed thanks from the Kings Arms

5 Guest Speaker

A presentation was given by Mark Rumsby from CAP (Christians Against Poverty). Firstly, he thanked **RT** for the grant of £6.5k over 2 years to specifically fund an administrator (Catherine Brown) for 1 day per week.

The Alton branch of CAP is one of 300, which extends beyond the UK. Mark highlighted and talked about the three categories of support that it provides:

- Debt help: increasingly they are working with those who cannot get day-to-day budgets to balance. The Alton branch has 2 debt coaches and 15 befrienders. It is emotionally draining for all involved but over the last 10 years everyone's efforts have meant that 103 households are now free of debt; 55% are single mothers
- Job club: assist getting people back into work. This initiative struggled at first but is now getting more attendees
- Money coaching course: helping people to use credit wisely, to budget and to save
