EPA Extends Deadline on PFAS Reporting Rule

On September 5, 2024, the U.S. Environmental Protection Agency (EPA) published a notice in the Federal Register extending the Toxic Substances Control Act (TSCA) reporting and recordkeeping deadlines for perfluoroalkyl and polyfluoroalkyl substances (PFAS).

The original reporting date for the rule was November 12, 2024. EPA has now extended the deadline by eight months to July 11, 2025.

In 2025, environmental regulation changes in the United States are expected to reflect the shifting political landscape and ongoing debates over climate policy. With a renewed focus on balancing economic growth and environmental protection, federal agencies such as the Environmental Protection Agency (EPA) are likely to implement updated regulations on greenhouse gas emissions, **contaminants of emerging concern such as PFAS and 6PPD**, and climate resiliency, targeting industries like energy, manufacturing, and transportation.

SPOTLIGHT ON: PFAS Regulations

Major PFAS manufacturer 3M has committed to ceasing production of all PFAS chemicals by the close of 2025. This is a huge shift in the world of emerging contaminants and goes hand in hand with stricter regulations around these chemicals. Starting in January of 2025, sales of many common products that contain PFAS, such as cookware, clothing, takeout containers, and cleaning products, will be prohibited or restricted in several states including California, New York, and Minnesota. Other states will surely follow suit, and we'll be keeping a close eye on how these policies inform environmental regulations across the country.
