Does your site need a SPCC?

YOUR GUIDE TO SPILL PREVENTION, CONTROL, AND COUNTERMEASURES (SPCC) PLANS



When are SPCCs required?

Facilities requiring SPCCs have a total aggregate capacity of aboveground oil storage containers greater than 1,320 gallons of oil, or a total aggregate capacity of completely buried tanks greater than 42,000 gallons of oil, and which have the potential to discharge oil to navigable waters of the US or adjoining shorelines.

How is capacity determined?

Containers less than 55 gallons are not included; however, when determining the oil storage capacity the maximum available volume of the container, NOT the amount of product simply held in the container at any particular time, must be used in the calculation.

What counts as “oil”?

Petroleum-Based Oils

- Gasoline
- Diesel Fuel
- Motor Oil
- Heating Fuel
- Jet Fuel
- Aviation Fuel
- Hydraulic Fluid

Non-Petroleum-Based Oils

- Animal-based Oil
- Vegetable Oil
- Biofuel

Oil-Containing Products

- Oil-based Paint
- Oil-based Thinner
- Oil-based Ink
- Oil-based Washer Solvent
- Roofing Tar

Under 10,000 gallons?

A facility may self-certify their SPCC rather than utilizing a professional engineer if it is prepared by a qualified entity.

Spill Prevention Programs

The Value of a Robust Spill Prevention Plan

Spill prevention planning is far more than a regulatory checkbox—it's a **critical component of responsible business operations that protects the environment, employee safety, and an organization's reputation and bottom line.** Each year, thousands of spills occur across industries worldwide, many of which could have been prevented with better planning. According to the U.S. Environmental Protection Agency (EPA), tens of thousands of oil and chemical spills are reported annually in the United States alone, releasing millions of gallons of hazardous materials into the environment.



The financial risks of spills can be staggering. **Cleanup costs alone can range from thousands to millions of dollars, depending on the material and scale of contamination.** Regulatory penalties add further expense: under the Clean Water Act, fines for unauthorized discharges can reach over \$60,000 per day per violation. Beyond direct costs, spills can damage a company's reputation, erode public trust, disrupt operations, and create long-term liability for environmental harm. In many industries, having a robust, documented spill prevention plan is also a prerequisite for maintaining operating permits and insurance coverage. **Ultimately, investing in spill prevention is investing in sustainable, responsible business.**



Training - Essential Preparation for a Spill

Employee training is an essential pillar of spill prevention. Even the best-engineered controls can fail if staff are unprepared. **Regular, practical training ensures employees know how to handle materials safely, spot potential hazards early, and respond quickly and effectively if a spill occurs.** According to industry surveys, organizations that invest in regular spill response training reduce average incident costs by up to 40%, highlighting the direct financial benefits of preparedness.

New California QSP/QSD Certification Prerequisite Courses!



California requires Qualified SWPPP Practitioners (QSP) and Qualified SWPPP Developers (QSD) to obtain certification through CASQA; however, certain prerequisite courses are required before an applicant can seek full certification.

CWT Academy is excited to announce that two new courses, [WCA0100](#) and [WCA0101](#) are available and approved by the California State Water Boards for fulfillment of required prerequisites!



Per California Code, a person can obtain a QSD or QSP certification through the CASQA by completing the following steps:

Step 1: Complete a required prerequisite to take the QSD or QSP training course (check out the links above!)

Step 2: Complete the QSD or QSP training course;

Step 3: Pass the QSD or QSP exam; and

Step 4: Register as a QSD or QSP through the CASQA website.

EPA ANNOUNCES MAJOR ROLLBACKS TO POWER PLANT POLLUTION LIMITS

Over the past month, the Trump administration's EPA leader has proposed rolling back Biden-era regulations that limited greenhouse gas and toxic emissions from coal and natural gas power plants—**rules credited with preventing thousands of deaths annually and delivering billions in health and climate benefits.** These proposed rollbacks, including lowering and weakening mercury and air-toxin limits, are being justified as cost-saving measures for the industry and the nation, but have sparked strong opposition from health and environmental advocates. Critics warn that allowing higher emissions could significantly worsen air quality, heighten public health risks,

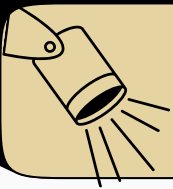

(especially for children and vulnerable communities), and undermine U.S. climate goals, potentially triggering legal challenges and regulatory uncertainty. Further, increased air deposition of heavy metals, particulates, and other such contaminants from these facilities **may make it more difficult for nearby entities with water quality permits - which would likely be unaffected by these emissions rollbacks - to achieve compliance.**

SPOTLIGHT ON: IDDE Programs



Illicit Discharge Detection and Elimination (IDDE) is a critical component of stormwater management programs designed to protect local waterways from pollution. **An “illicit discharge” is any unauthorized flow into a storm drain system that is not composed entirely of stormwater—such as sewage, industrial wastewater, vehicle wash water, or other contaminated runoff.** These discharges can introduce harmful bacteria, nutrients, heavy metals, oils, and toxic chemicals into streams, rivers, and lakes, threatening public health and ecosystems.

Under the Clean Water Act, **many municipalities are required to develop IDDE programs as part of their MS4 (Municipal Separate Storm Sewer System) permits.** A strong IDDE program typically includes mapping storm drain systems, conducting inspections, sampling outfalls during dry weather to identify suspicious flows, and investigating sources of contamination. Public education is also essential, helping residents and businesses understand what constitutes an illicit discharge, how to prevent them, and/or how to properly dispose of waste products rather than dumping.

By proactively identifying and eliminating these unauthorized discharges, communities can significantly reduce pollution at its source.
