AGRICULTURE MEETS STORMWATER: NEW WASTE DISCHARGE RULES FOR SAN JOAQUIN GROWERS

California's approach to protecting water quality just took a bold step into agricultural territory. Under the latest Waste Discharge Requirements (WDRs) for the Eastern San Joaquin River Watershed, **growers must now meet rigorous standards for stormwater and irrigation runoff—marking a strong collaboration between water boards, third-party groups, and farmers.** From required Irrigation and Nitrogen Management Plans to certified Sediment and Erosion Control Plans, growers are tasked with implementing BMPs that reduce nitrate loading, protect groundwater, and address

legacy pollution. **With over 450 miles of impaired waterways in the region, these changes are vital—and costly, averaging \$118.55/acre annually in compliance.** This represents a key example of how stormwater regulations are evolving to address agricultural impacts. SPOTLIGHT ON: California Water Boards

The California State Water Resources Control Board plays a central role in safeguarding the state's water quality and managing its limited water resources. Established in 1967, **the Board is tasked with protecting surface and groundwater, enforcing the federal Clean Water Act and state water laws, and ensuring safe drinking water for communities.** Working through nine Regional Water Quality Control Boards, it oversees permitting, water rights, pollution prevention, and stormwater management, while balancing the competing needs of cities, agriculture, industry, and the environment.

The Water Board's policies aim to promote conservation, improve water recycling and reuse, and protect vulnerable communities impacted by contaminated or unreliable supplies. From enforcing stormwater permits to supporting groundwater sustainability projects, the Board's work is vital in shaping California's water future — ensuring that this essential resource is managed responsibly for both present and future generations.

The Board also emphasizes the importance of professional credentials and training, recognizing that qualified, well-prepared practitioners are essential to achieving effective water quality protection and regulatory compliance.
