SSA Update ... By Mimi Patterson

Holmes DD, like all County Boards of DD in Ohio, had to stop providing adult day program services and transportation due to a Medicaid mandate. This was a big change over the summer and it impacted some adults who receive services from Holmes DD. People still have questions about why it happened and what it really means for their loved one.

Just recently I was on the phone with a mother who asked, "will my adult daughter who attends a new adult day services program still have an SSA?" I responded "well of course! What makes you ask?" The mother said, "since my daughter no longer attends Holmes DD's adult service program, I just thought my daughter would no longer receive any Holmes DD services." I responded, "as long as your daughter is enrolled in services funded and/or coordinated by Holmes DD, she will have an SSA." This conversation put this mother's mind to rest as she had anticipated even greater changes in her daughter's life.

I want to use this newsletter to share important information. Holmes DD is required to provide Service and Support Administration (Case Management) to anyone over age 3 who is eligible for Holmes DD services and wishes the support of an SSA. SSAs are here to listen, address your concerns, and provide you with resources and support. Holmes DD SSAs write Individual Service Plans which authorize services so providers like, GentleBrook, Midwest Community and Precious Angels get paid. Holmes DD SSAs also authorize services for those folks receiving care in the homes so providers like, R.H.D.D., D.O.Y and State Wide Transportation get paid. Most importantly, Holmes DD continues to be responsible for ensuring the health and welfare of all individuals with developmental disabilities living in Holmes County.

If you are a parent, guardian, brother, or sister of someone served by Holmes DD and you have questions about the services your loved one is receiving, please reach out to the SSA Department anytime.

Early Intervention Update

One of the largest changes to ever happen in Holmes County's Early Intervention program took place in July. Holmes DD became responsible for the service coordination portion of Early Intervention. The EI team is extremely excited to have the entire program housed in one agency.

For almost 20 years, service coordination was housed at the Health District because the State of Ohio felt it was necessary to separate service coordination and developmental services/ therapies. Over time, changes to EI programming resulted in eliminating the need to house service coordination in another agency. As a result, many counties have brought service coordination and developmental services together at their County Board of Developmental Disabilities. Holmes County is now the 51st county in Ohio to make this change.

The benefits of all EI services housed by one agency are many! Time saved through efficiency is particularly valuable because the developmental specialists and therapists can spend more time providing services. Money is also saved because less time is spent administratively. But one of the biggest benefits is that families will receive EI services with fewer initial visits and less paperwork while only engaging with one agency.

We were very fortunate to be able to hire the person who was Service Coordinator at the Health District, Monique Jacobs. Not only is she key to a smooth transition, but Holmes DD now has this wonderful person with outstanding character as an employee!

Superintendent's Message

I am often asked, "what do you do in the summer since school is closed?" Let me tell you, we do a LOT over the summer. And this summer, more than any other summer, we had a lot going on. First and foremost, many adults who had received adult day services from Holmes DD transitioned to GentleBrook, a new provider to Holmes County. Even though we were expecting a change like this for years, it still felt a little unsettling. To provide a proper send-off, a commemorative event was held in late June where we remembered the staff, adults, and memories made over the 50 plus years that Holmes DD/Training Center provided adult services (see the photos below). More than 100 people attended to show support and thank the retiring staff members. GentleBrook began adult services in July and have developed positive relationships with the individuals served. Another big change over the summer came when Holmes DD was awarded a grant to provide Early Intervention (EI) Service Coordination. Dave's Safety Corner—Fire Extinguishers

Fire extinguishers are classified into classes based on what type of fire they will extinguish. The following three classes are the common household fire extinguisher classes.

Class A—Flames are caused by wood, cloth, or paper.

Class B—Flames are caused by liquids and gases.

Class C—Flames are caused by energized electrical sources.

Less common fire extinguishers are for class D and class K.

Class D—Metal fires involving magnesium, sodium, potassium, and sodium potassium alloys.

Class K—Kitchen fires—flames involving grease, cooking fat, and oils.

When using a fire extinguisher, use the PASS method to quickly and efficiently extinguish the flames.

P—Pull the pin

A—Aim at the base of the fire

S—Squeeze handle

S—Sweep side to side

School Bus Safety Reminder



A few safety reminders are the buses hit the road again.

- Do not pass a school bus that has red alternating flashing lights on. This is the signal that the
 bus is stopped to load or unload children. Traffic should not move until the bus resumes motion or the driver signals traffic to proceed.
- When a bus has alternating flashing amber (yellow) lights on, it is preparing to stop to load or unload children. Be ready to stop and watch for children in the roadway.
- If a bus is stopped on a street or road that has fewer than four lanes, all traffic proceeding in either direction must stop.
- You must not proceed until the school bus resumes motion, or until signaled by the school bus driver to proceed.

HCAHC Update

At the August HCAHC Trustee meeting, changes were approved that go into effect in September. The hourly rate for respite care has increased to \$15/hour; \$20/hour if working with two individuals with disabilities at the same time. The maximum allowable for respite that can be funded by HCAHC is \$2500/yr if there is one person with a disability in the family; \$3500/yr if there are two individuals with disabilities in the family. The mileage reimbursement rate has increased to \$1.25/mile.

Agencies serving people with developmental disabilities can now request grant funding from HCAHC for things like specialized equipment and program expenses. Individuals and families of people with developmental disabilities can also request grant funding for camperships, emergency respite, therapy, and adaptive equipment.

HCAHC continues donations in 2022-23 to New Leaf Clinic, Caring Hands, OCCF, Holmes DD Levy Campaign, Holmes County Special Olympics, Special Needs Library, and Share-a-Christmas.

The annual membership fee has increased to \$20. Soon, membership applications will be sent to last year's members. If you would like to become a member or submit a grant application, please call (330) 674-8045 and ask for Callie.
