3. What Data We Collect

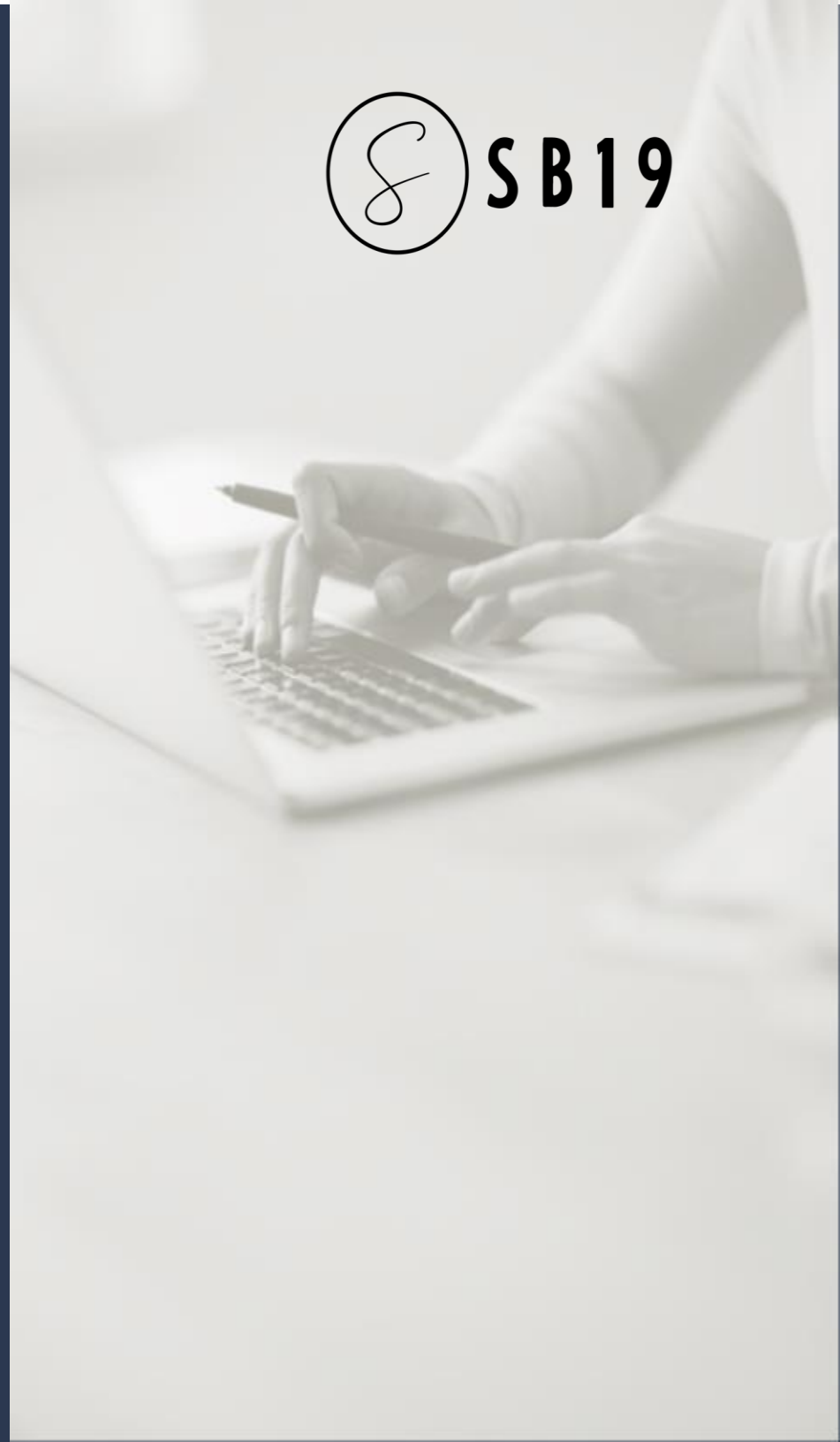
We may collect and process the following types of personal data:

- Identity Data: Name, date of birth, nationality, ID documents.
- Contact Data: Address, phone number, email.
- Financial Data: Income, assets, liabilities, credit history, bank details.
- Business Information: Company ownership, director/shareholder information, financials.
- Technical Data: IP address, browser type, cookies (when visiting our website).
- Correspondence Data: Emails, calls, and other communications.

4. How We Collect Your Data

We collect data from:

- Information you provide directly through forms, meetings, calls, and email.
- Third-party sources such as credit reference agencies, publicly available registers (e.g., Companies House), and identity verification services.
- Automatically via our website using cookies and analytics tools.





5. Purpose of Data Processing

Your data is processed to:

- Assess your finance or advisory requirements.
- Conduct due diligence and comply with legal obligations (e.g., AML checks. Facilitate introductions to suitable finance providers. Communicate with you during our engagement.
- Send relevant marketing communications (if you have opted in). Maintain regulatory and internal business records.

6. Legal Basis for Processing

We process personal data under the following bases:

- Contractual necessity
- Compliance with legal obligations
- Legitimate interests
- Consent (where explicitly given, e.g. for marketing)

7. Sharing Your Information

We may share data with:

- Banks, lenders, and financial institutions.

- Regulatory authorities (e.g. HMRC, FCA, ICO) as required.
- IT service providers and cloud-based software platforms (under data processing agreements).

We do not sell or trade personal data.
