As a reminder to all BEC students, lesson payment is due in full to the instructor at the beginning of each lesson. Since the lesson charge depends on the number of students that show to take the lesson, you are responsible for checking with the instructor to determine what type of lesson the student will be charged before you write your check.

For your convenience, we maintain lesson ledgers that allow you to pay for a block of lessons in advance. If you choose to pay by lesson ledger, it is your responsibility to check with the office regarding your lesson ledger balance. We do not send statements or call with your lesson ledger balance.

We have instituted a \$15.00 administration fee applicable to anyone who does not pay in full at the beginning of each lesson. **** _____ SECTION II WARNINGS AND ASSUMPTION OF RISK AGREEMENT**

- A.** I/We understand that horseback riding is classified as RUGGED ADVENTURE RECREATIONAL SPORT ACTIVITY and that there are inherent elements of risk always present in any such activity despite all safety precautions. I fully accept such risk, some examples of which are listed as follows:

- 1) THIS STABLE** chooses its horses because they have docile personalities and basic training required for use as lesson horses by amateur riders, and it follows a rigid safety program. In spite of this it is not possible for any person or establishment to predict exactly how a horse will behave when it is frightened, angry or under stress; it may react according to its natural instincts which are to jump sideways, forward or backward, to run away from danger at a trot or gallop, to kick with its hind legs, to strike with its forelegs, to buck, to rear up in front, to bite and/or to throw its head upward or sideways. Statistically horseback riding ranks 64th on a list of dangerous sports. Generally, riding a well-trained, quiet lesson horse over moderate terrain is statistically as safe as or safer than riding a bicycle on a Public Street, road or trail for the average person. The more obvious ways (there may be others) in which a horse may be dangerous under these circumstances are:
 - a)** Riding is the only sport where one much smaller, weaker predator animal (human) with a mind of its own tries to impose its will on another much larger, stronger prey animal with a mind of its own, where each has a limited understanding of the other, yet tries to become one unit of movement, Prey animals are always judiciously cautious for their survival. The brain-mind factor of the horse can work either for or against the rider.
 - b)** Smoothness and speed of ride or horse's gaits may be irregular at times. Horses move at three usual gaits: walk, trot and gallop. Each gait's motion is unique.
 - c)** Distance to the ground is usually further on a horse, and riders who fall usually fall on the upper body. During a fall there is the potential for the horse's larger body to interfere with the rider.
 - d)** Horses are 5 to 15 times larger, 20 to 40 times more powerful, and 3 to 4 times faster than a human. Horses move under their own power.
- 2)** Upon mounting a horse and taking up the reins the rider is in primary control of the horse and his safety largely will depend upon his ability to carry out simple instructions, and also upon his or her own ability to remain balanced at all times while aboard the horse or even while on the ground. If a rider falls from a horse to the ground, it will be at a distance of from 3 ½ to 5 feet and impact will be according to physical law, possibly resulting in injury to a rider.
- 3) THIS STABLE** is not responsible for acts or occurrences of nature that can scare a horse or cause it to fall. Some examples of such acts or occurrences of nature are: Thunder, lightning, rain, wind, water, wild and domestic animals, insects, reptiles, etc., which may run or fly near or bite a horse or person and irregular footing on out-of-door groomed or wild land which is subject to constant change in condition according to weather and natural changes in landscape.

- 4) For the safety of all, riders must not carry loose items on rides which may fall, blow away, flap in the wind, and possibly scare a horse, such examples being handheld cameras without neck straps, hats not securely fastened under chin, toys, clothes not actually worn which are not securely tied on saddle or person, beach towels, purses, and wallets, etc. Likewise, riders must not make sharp, loud noises, such as screaming which may scare a horse.
- 5) Saddle girths may naturally loosen during ride and if rider notices this, they should alert the nearest instructor as quickly as possible to avoid any slippage of the saddle. Also, for purposes of safety and balance, once mounted the rider should position his feet into the stirrups on the balls of the feet, not behind on the arch nor ahead on the toe, then flex the ankles to raise the toe end of the feet upwards then solidly press or step the balls of the feet down firmly onto the stirrup base.

** _____ SECTION III RELEASE AGREEMENT:

- A. I/WE understand and agree that except in event of THIS STABLE'S gross negligence, I/WE accept full responsibility for bodily injury, property damage, death, medical and other financial loss expenses to include, but not limited to, time lost from school or work or disability, which are sustained by any member of my group so listed above, on or in relationship to the premises and operations of THIS STABLE and/or while riding or handling horses or other animals owned by same and that I/We hereby, for myself, my heirs, administrators and assigns, do hereby release and discharge the owners, operators, sponsors of the premises and their respective servants, agents, officers and all other participants of and from all claims, demands further that I/WE can be held legally responsible for injuries to THIS STABLE'S animals and/or property, and also for bodily injury and/or property damage, and/or death to their which I/WE may cause should I/WE not act in prudent and cautious manner at all times.
- B. I/WE have been fully warned by THIS STABLE that I/WE can protect ourselves against head injuries by wearing protective head gear while mounting, riding, dismounting and being around horses. Mark an "X" below in the box before the appropriate sentence which relates to your desires regarding the wearing of such equipment by you and your group on the ride(s) in which you are contracting herein to participate.

☐ I/WE request riders to wear protective head-gear which THIS STABLE will provide, understanding that these may not be of perfect fit for each rider's head, and once provided I/WE will be responsible for securing these hats on rider's heads at all times.

☐ I/WE will wear protective headgear which I/WE are providing and I/WE accept full responsibility for this decision.
- C. I/WE consent to any x-ray examination, anesthetic, medical or surgical diagnosis or treatment and hospital service that may be rendered to said minor under the general specific instructions of any physician or hospital. It is understood that this consent is given in advance of any specific diagnosis or treatment which may be required but is given to encourage Brunson Equestrian, LLC/ Kathy Brunson, staff, and such physician to exercise their best judgements to the requirements of such diagnosis or treatment. The undersigned shall pay all fees for doctors, hospital, ambulances, and other medical charges responsible and necessarily incurred. This release shall be in full force and effect until it is withdrawn by student or student's parents or guardians, in writing. Please note any other medical information that will be needed for treatment (i.e., allergies, allergic reactions, etc.).

RULES FOR STUDENTS

- 1) Students must wear hard-soled boots or shoes with minimum one-half inch (1/2") heel. No tennis shoes or slip-on shoes.
- 2) Students must wear ASTM/SEI standard certified equestrian riding helmet at all times.
- 3) No jumping without an instructor present.
- 4) Scheduled lessons may be cancelled by student. Minimum 24 hours' notice is required, or student shall be liable for payment in full.
- 5) Although every effort is made to encourage students of semi-private or group to make their lesson, the charges for each lesson will be determined by the services rendered. (i.e., group lesson-2 students show up –semiprivate charge \$60.00 per student, group lesson- 1 student shows up –private lesson charge \$75.00)
- 6) Students are responsible for putting up all tack and equipment at end of lessons.
- 7) No horse is to be left unattended.
- 8) Lessons must be scheduled in advance, minimum 24 hours' notice.
- 9) Payment is due in full on the day of lesson prior to riding. Cash or check, no credit cards. Checks should be made payable to Brunson Equestrian Center.
- 10) Lessons may be cancelled due to weather. All reasonable attempts will be made to contact students in case of cancellation. In case of inclement weather, it is best to call 1 to 2 hours prior to scheduled lesson time to verify that lessons have not been cancelled. Do not assume cancellation. (See rule #4)
- 11) Parents of students are encouraged to watch lessons. Instructors request that spectators remain quiet during riding time. Comments and/or questions may be addressed to student or instructor before or after lessons.
- 12) All minor children must be accompanied by an adult.
- 13) Students must be familiar with, and comply with, all other ranch rules (see page 7 of 7).

BRUNSON EQUESTRIAN, LLC GENERAL RANCH RULES

- 1) **THE NO RULES:** Absolutely, positively
 - No riding without wearing a riding helmet (**anyone under the age of 21 years old**).
 - No jumping unless an instructor is present.
 - No smoking in the barn.
 - No riding in the barn.
 - No grooming or saddling horses in barn aisle - use your stall.
 - No running, no yelling, no raucous behavior in the barn or on the property.
 - No dogs at the barn, you may **not** bring your dogs on the property – **no exceptions**.
 - No excessive alcoholic drinking allowed on Brunson Equestrian, LLC grounds.
 - No unattended minors. Parent or responsible adult must accompany any and all children. When an instructor is on the property it is for the purpose of giving lessons and preparing for lessons. Instructors are only responsible for the students in their lessons. Asking instructors to watch children during this time is unsafe and unacceptable. Please make other arrangements for your children if you are unable to supervise their time at Brunson Equestrian, LLC.
- 2) Never tie a horse to any part of a car or truck **for any reason**.
- 3) Horses may be tied to hitching posts only. No tying horses to any fencing.
- 4) Please keep aisles of barn clear at all times and we suggest you label all your equipment with your name.
- 5) Do not handle horses other than your own.
- 6) Never feed a horse treats unless the horse belongs to you.
- 7) **Do not** borrow a halter or lead rope hanging on front of someone's stall.
- 8) Keep the tack room neat. Put all tack in proper order.
- 9) **Do not** borrow other people's tack or equipment without the knowledge and permission of the owner.
- 10) The last person out should make sure tack room is locked and all lights are turned off.
- 11) You may not turn your horse out or let it run loose unattended in the paddock or arena.
- 12) Brunson Equestrian, LLC may turn horses out in the arena on certain days. If there is a loose horse in the arena and you wish to ride, find the horse owner or one of the Brunson Equestrian, LLC staff to catch the horse and put it up before you enter the arena.
- 13) If a lesson is in session and you wish to enter the ring you will need permission from the attending instructor first. When riding without an instructor present you must use the buddy system.
- 14) Arena lights are to be on only when riding or working a horse.
- 15) Clean up all public areas that you use when finished.
- 16) Trash containers are provided in central areas, please use them.
- 17) Always turn all lights off when finished and close any gate that you open.
- 18) **Do not** use any Brunson Equestrian, LLC tack, equipment, feed, hay, and/or medicines without the express permission of an authorized Brunson Equestrian, LLC staff person. (Manager or trainer.)
- 19) The horse owner must notify Brunson Equestrian, LLC in writing if anyone else will be taking care of or riding his or her horse. Any and everyone who rides or takes care of a horse at Brunson Equestrian, LLC must have a current and completed release form on file in the office – **NO EXCEPTIONS**.
- 20) You are required to provide Brunson Equestrian, LLC with a copy of annual Coggins, shots, and worming.
- 21) Veterinary and farrier bills are the responsibility of the horse owner. Payments for services should be made directly to the provider. Brunson Equestrian, LLC will not act as intermediary.
- 22) Thirty (30) day written notice that you are terminating your board contract and moving is required on or before due date of boarding contract. (You will be charged for a full month.)
- 23) Monthly board fee is due on the date specified in the individual board contract. A 10% late fee is incurred 10 days after specified day.
- 24) All checks should be made payable to Brunson Equestrian, LLC. (Board and lessons.)
