All sessions are available to virtual participants; the Virtual Presentations refer to presenters who are not onsite, i.e., they will be presenting virtually.

ZOOM CONFERENCE RULES

1. Video & Audio should be kept OFF
2. **QUESTIONS** can be typed in the ZOOM Session Chat during the Q&A or by using the mic and will be prompted by the host. If your question is not answered during the Q&A session, it will be answered later and posted on the CAP website.
