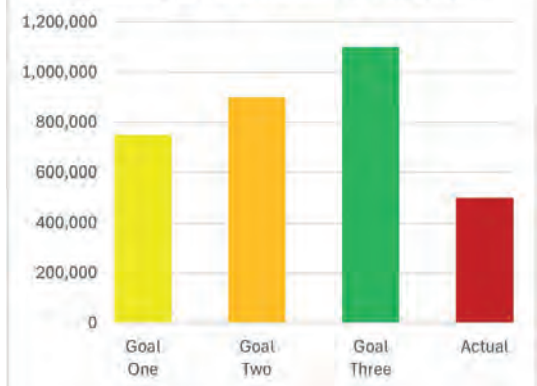

FROM THE PASTOR'S DESK: Building Up the House of the Lord: Called in Christ to Be a Holy People

As we gather on this **Second Sunday of Ordinary Time**, the Church places before us a beautiful and challenging theme: **"In Christ, we are called to be a holy people."** Holiness is not an abstract ideal reserved for a few; it is the daily vocation of every baptized person. It is the

call to live with purpose, generosity, and love. It is the call to build up the Body of Christ—not only spiritually, but also in the very places where we worship, gather, and serve.

This weekend, as we reflect on our parish's future, this theme becomes especially meaningful. Our **Building Up the House of the Lord Capital Campaign** is not simply about bricks and mortar. It is about answering Christ's call to holiness by strengthening the spiritual home where we encounter Him, where we form disciples, and where we serve the needs of our community.

Over the past several weeks, many of you have responded to this call with remarkable generosity. **Approximately 80 families have already pledged \$428,000** toward our campaign. This is a tremendous beginning, and I am deeply grateful for every family who has stepped forward in faith. Your early leadership is a sign of hope and a witness to the holiness to which Christ calls us.

Yet we are still on the journey. To move forward with **Tier One**—the construction of our new **gathering space and community center**—we must reach **\$750,000 in pledges**. This is the threshold that will allow us to break ground and begin transforming our parish campus in ways that will bless our community for generations.

Why This Project Matters for a Holy People? Holiness is lived in community. It is nurtured in the spaces where we pray, learn, serve, and share life together. Our parish is vibrant and growing, but our physical space has not kept pace with our needs. A **gathering space** is not merely an architectural addition—it is a pastoral necessity. It is the

place where the parish becomes a family.

Imagine a space where new parishioners are welcomed warmly, families can linger after Mass, ministries can meet without competing for limited rooms, Faith formation can flourish, and hospitality becomes a hallmark of our parish identity.

A **community center** will allow us to host formation programs, receptions, meetings, and events in a space that is accessible, comfortable, and designed for the needs of a modern parish. These are not luxuries—they are essential tools for building a holy people.

This project also prepares us for the future. As our parish continues to grow, we may one day need to **expand the seating capacity of the church**. By building the gathering space now, we create the structural flexibility to expand later in a **cost effective and efficient way**. Tier One is not only about today—it is about wise stewardship for tomorrow.

This weekend also leads us into the celebration of **Martin Luther King Jr. Day**, a moment when our nation reflects on justice, community, and the sacred dignity of every person. Dr. King's vision of the "beloved community" resonates deeply with our Christian call to holiness. Holiness is not isolation—it is mission. It is the willingness to build a community where every person is welcomed, valued, and supported.

Our capital campaign is an expression of that mission. By strengthening our parish home, we strengthen our ability to serve the poor, support families, form disciples, welcome newcomers, offer hospitality, and provide ministries that heal, teach, and uplift. A parish that invests in its mission becomes a parish that can better reflect the holiness of Christ to the world.

Dr. King once said, *"Faith is taking the first step even when you don't see the whole staircase."* Our campaign is such a step. We may not see every detail of the future, but we know the Lord is calling us to build, to grow, and to prepare the way for those who will come after us.

Your Participation Makes a Difference. To reach our Tier One goal, we truly need **every household** to participate. No gift is too small. What matters most is that each of us makes a sacrificial commitment that reflects our love for the Lord and our hope for the future of our parish. I have

asked parish families to try to recommit the same pledge you made in 2018 for the Catholic Strong Campaign. If your circumstances prevent you from doing so, would you prayerfully try to commit to a pledge of \$3,600 paid over three years. This comes to an additional \$100 per month in addition to your ordinary offertory to the parish, and your support of the poor through the House of Charity (South Jersey Catholic Ministries Appeal). All I ask is that you do what is right in your circumstances before God.

If you have not yet submitted your pledge, I ask you to prayerfully consider doing so this week. Your commitment moves us closer to beginning this essential first phase. Together, we can reach the \$750,000 needed to break ground and bring this vision to life.

Our parish was built by the sacrifices of those who came before us—families who gave generously so that we could worship in a beautiful church, receive the sacraments, and grow in faith. Now it is our turn to build for the next generation. The decisions we make today will shape the parish our children and grandchildren inherit.

To be a holy people in Christ is to be a people who build—who invest in the mission of the Church, who strengthen the community of faith, and who prepare a spiritual home worthy of the Gospel. Let us respond with the same courage, generosity, and trust that have always defined our parish. Let us **Build up the House of the Lord**—not only in stone and mortar, but in faith, hope, and love.

May Christ, who calls us to be a holy people, bless our efforts, guide our decisions, and unite our hearts as we take this important step together.

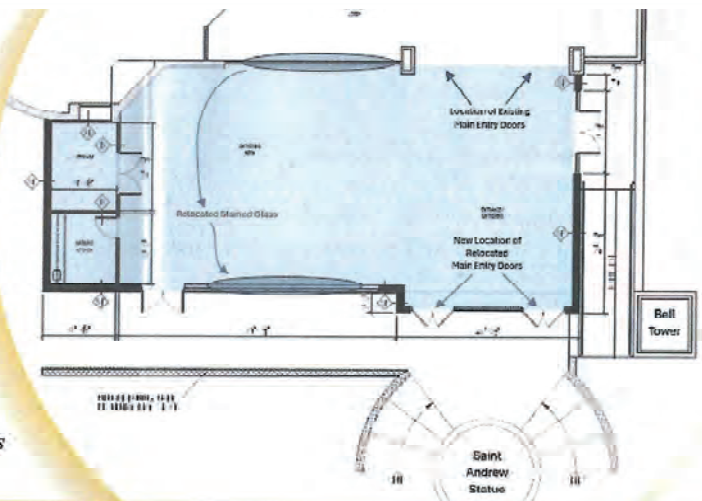

Joseph's House Monthly Casserole Recipe

Happy New Year!!! The management team at Joseph's House asked me to wish you all a BLESSED New Year!!!! Thank you volunteers for your continued commitment to this ministry. In addition to casseroles, we will continue collecting individual snack bags for Joseph's House clients. The next drop off for casseroles will be Thursday, January 29, 2026 from 10-11 AM. Drive up to the parish hall and a volunteer will be there in the parking area. We will hand deliver to Joseph's House later in the day. If this day and time do not work for you, we can make other arrangements. Call or text Chris Parry at 856-906-5127 with any questions and/or to confirm you will make a casserole. Prepare one or more casseroles. All donations are deeply appreciated. We will continue to use the same recipe.

Hamburger Noodle Casserole

1 lb. hamburger beef	1-cup cottage cheese
15 oz. can or jar tomato sauce	1-cup sour cream
1 medium chopped onion	12oz. egg noodles
1 cup of green pepper	2 cups Shredded Monterey Jack Cheese

Combine the hamburger, green pepper and onion and sauté until meat is cooked. Salt and pepper to taste. Add tomato sauce and simmer for 20 minutes. Cook noodles according to package directions. In another bowl combine sour cream and cottage cheese. Blend cottage cheese and sour cream mixture with the cooked noodles. Salt and pepper to taste. In a lightly greased aluminum pan spread the hamburger mixture. Next, layer the noodle mixture. Top casserole with shredded Monterey Jack cheese. Bake at 350 degrees for 20 minutes or until thoroughly heated. NOTE: Please freeze the casserole, cover with aluminum foil, date and label St. Andrew's- "Hamburger Noodle Casserole."

The Blessing of the Throats in honor of the Feast of Saint Blaise will be held at all masses on Saturday, January 31st, and Sunday, February 1st. A general blessing will be given over the congregation after the announcements but before the final blessing. Individual blessings will also be offered after the final blessing during the final hymn. Through our Lord Jesus Christ, our sins are forgiven, death is overcome, and life is victorious. “Hope dwells as the desire and expectation of good things to come, despite not knowing what the future may bring.” Because of this Christian hope, we can face the unknown trials of life with faith rather than fear.

We are called to be signs of hope to all people, especially those whose goodness, value, and dignity are undermined. As members of the Body of Christ, we carry this hope with us as we continue Jesus’ mission on earth. Pope Leo XIV encourages us, “How important it is that each and every baptized person feel himself or herself called by God to be a sign of hope in the world today.”

Sadly, there is a devastating absence of hope today. We see this most profoundly in a sweeping disregard for human life in its most vulnerable forms and stages. Abortion and assisted suicide are products of hopelessness and despair. Yet even amid the increasing attacks on

human life, we know that the “storms that buffet us will never prevail, for we are firmly anchored in the hope born of grace, which enables us to live in Christ and to overcome sin, fear and death.”

We have been entrusted with a message of hope for the woman who finds herself unexpectedly pregnant or for the man diagnosed with a terminal illness. At these challenging moments, we must bring God’s presence, witnessing to His love, and inspiring a renewal of hope in those whose hearts are burdened. For “hope is born of love and based on the love springing from the pierced heart of Jesus upon the cross.”

Having been “buried with Christ in Baptism, we receive in his resurrection the gift of a new life that breaks down the walls of death.” Confident of God’s presence within us, may we share the Gospel of Life with those most in need of hope, knowing that “the grace of God precedes and accompanies his people as they press forward firm in faith, active in charity and steadfast in hope.”
