God is positioning individuals, nations, and entire systems in place for His people, and for His end-time purpose. God is shaking everything from governments, to markets, to relationships, so that which is unshakable will remain, and that which is sifted will blow away like chaff.

This is a time for the righteous disrupters to rise and gloriously disrupt unto justice, a time for the mature prophetic intercessors to pray with now-time, real-world intel, and a time for miracle workers, and reformers to be on task. These will help shift our real-world condition over to our birthright positions, while in the midst of a scripted Civil War.

Now, whether we recognize it or not, we are in a battle for the soul of our nation, for our very souls, for our churches, our national and kingdom identities, even the national narrative itself. **Now, with immense respect**, the primary challenge most believers outside the four walls are experiencing with those on the inside, is you guys simply choose not to partake in the gifts given to other parts of the body who serve the same King and the same kingdom as you do. We are willing and most capable of offering deeper insights into what you guys are seeing, hearing and discerning from our Heavenly Father. Kingdom business should be a team effort on all fronts. But you guys are reluctant to engage or unify beyond your familiar circles, which ultimately limits all our shared growth and forward motion. By assuming our perspectives are merely conspiratorial does not reflect the care or sincerity with which they are offered.

Most churches today turn away from the uncomfortable truths regarding their own condition; from the deeper realities that they truly face. There is a reluctance with leadership to thoroughly examine **“real foundational remedies”** which God and our forefathers have bestowed and bequeathed to us. While at the same time they wholeheartedly place their trust in a political party who covertly crafts political narratives, specifically created for their consumption. Within these political and religious confines, we find ourselves immersed in a profound and intense spiritual conflict, where most of the body of Christ does not recognize the extent to which they are being controlled, divided, distracted, and deceived. Hence the reason for these letters.

As real foundational truth and connected prophecies begin to show themselves in the natural world, the 5-fold Ministry within the 4 walls (*by their own vagueness, no offense given*) doesn't seem to truly understand the real-world impact or the implications these things bring? It seems their understanding of national and international politics is very vague at best.

**With Eternal Respect**, most Evangelicals tend to blend and mix together everything within the religious and political realms, into one big pot of stew, without ever properly differentiating our sovereignty, the three parts of our national sovereign government, the three commercial jurisdictions, the 3 different forms of law that govern each jurisdiction, the principalities involved in the lower two levels of our federal government, nor all the players, actors, or agents thereof.

These matters are foundational and essential to be understood and kept rightly divided, so that the narrative itself may be discerned with all clarity. More importantly, they must be clearly understood by **the apostles and prophets**, so that the narrative may be faithfully conveyed to the body. Only then can we come into true, real-world alignment in our divine identity and shared cause, especially during active prophetic seasons, appointed times and windows.

Prophecy is not just for those inside the 4 walls. God's word is also for His covenant people throughout the natural world of His creation. Who live and move and worship Him outside of the religious confines of those 4 walls”.

## **“The Fall & Destruction of Babylon in the words of Yeshua Hamashiach.**

*(Will you know it, when you see it?)*

**This people have I formed for Myself; for My purpose, they shall show forth My praise.** (*The redeemed and adopted ones of Yeshua, The Great King of Judah. The redeemed of The Royal Governing House of Judah; those grafted onto the whole family tree of Israel*)

But thou hast not called upon me, O Jacob; thou hast been weary of me, O Israel. Thou hast not brought Me your offerings; neither hast thou honored me with your sacrifices. I have not caused thee to serve with an offering, nor wearied you with incense, **but thou hast made Me to serve with thy sins, thou hast wearied me with thine iniquities.**

If we, the covenant people, are not defending our own nation through our birthright inheritances, then we are certainly not defending the Kingdom of God within it, as they are designated to work together.

As the old matrix collapses, the secular/commercial world is actively constructing a new, upgraded system to replace it. Even as we watch all the widespread federal fraud being exposed, the church is still unaware of the gravity of her own situation, and her entanglement with the same fraudulent system. Therefore, it is necessary to expose 160 years of systemic deception, fraud, spiritual seduction, and witchcraft exercised upon every Christian denomination.

Quoting **Donald J. Trump** - "This is going to be Fraud like you've never seen!" "They are after you, they are after everything we stand for, your freedom, your rights, your prosperity, and your country. They are trying to take it all away. (*through Commercial Fraud*) It will be "Americans of faith" who are going to save this country!" -end quote

Therefore, it is fair to conclude that anyone who has not witnessed the level of this fraud cannot fully grasp its real scope. We have seen it, and we understand it clearly. What stands before us today is not an isolated wrongdoing, but more than 160 years of continuous commercial fraud carried out by our foreign federal subcontractors. Fraud that has been allowed to expand unchecked by the Nation's Primary Contractor and Preferential Creditors, which is you and I. In other words, it is **We the People** and **We the Covenant people** who were meant to oversee it, restrain it and fund it, not for the foreign subcontractors who we hired to operate it.

That very fraud Trump spoke of, and the greater truth as well, is illuminated by the very framework in which our constitutional republic was founded, and how the principles of the Kingdom of God were intentionally interwoven within its earliest foundation.

Our national covenant forefathers, drawing upon divine providence and centuries of inherited wisdom, constructed a sovereign form of government grounded in natural law, common law, public law, biblical morality, and the sovereignty of the people under God ...and under His law.

They established not only the structural framework of our government, but also the form of law intended to guide and regulate its sovereign operations, as well as its commercial operations under delegated authority.

In parallel of our sovereign framework, this same divine pattern reflects the establishment of the sovereign government of the Kingdom of God within the nation. The Kingdom government is structured for the holy priesthood (*the 5-fold Ministry of Christ*) to administer God's intention through His Word, and through His precepts and principles for the natural world, for the progression of both nation and kingdom. - As Christ's kings and priest.

This order functions not merely as a religious concept, but as the higher law from which all earthly authorities derive their legitimacy. Thus, the national framework crafted by our founders and the ecclesiastical order appointed to us by Christ, also established by our covenant forefathers, both stand in complementary relationship to one another in the roles of "kings & priest": one forming the temporal republic, the other establishing the eternal Kingdom of Yehovah within the republic, by the Order of the holy priesthood, both designated to operate in harmony together.

We must clearly understand, that the greater truth in this notice, exists beyond the reaches of the D.C. apparatus, beyond the 2-party political system of the Republicans and the Democrats, and we must be willing to position ourselves on the outer courts, well beyond the political machine, and stand above all its noise and limitations, so that we can look upon it with a clear panoramic perspective, seeing all parts and all parties involved.

Only from that vantage point can we rightly discern all things, all people groups, their properly assigned places and the divine order of it all, even how Christ Himself established this nation and ordered it for His glory, through the hands and mouths of our founding fathers then, and through the hands and mouths of their birthright heirs today.

Herein lie our orders, written into our very foundations and frameworks, orders that illuminate Christ's intent for us as a people, and His purpose for us in this sovereign nation. These orders call

us to carry forward both the covenants of the nation and the covenants of the Kingdom, entrusted to the hands of the lawful, sovereign, birthright heirs of this nation, and the order of that holy priesthood, to administer not for our own elevation, but in humility and faithful service to His people, and to the nation and the Kingdom, in righteousness and in justice unto His glory.

Another large unknown truth is also about **how our federal government's frameworks are set up and established, and the forms of law that govern the foreign commercial jurisdictions in the District of Columbia.** These foreign jurisdictions are governed by foreign government service providers through commercial contracts and treaties. These work directly for **The United States government** under the limited authority of their **Corporate Charters.** They were established out of necessity, so that **We the sovereign people of the Soil & land Jurisdiction** could have vessels to operate in commerce, upon the **international sea** and the **global air** Jurisdictions.

These **foreign government service providers** only stand in the foreign commercial jurisdictions of our country. **Not in the sovereign, as We the people do.**

**They are foreign subcontractors in every sense of the word.** They are here in this country, only, to provide government services for **We the people and our Sovereign government.**

The sovereign soil jurisdiction of this country is the organic jurisdiction; it is part of the natural realm of our God and is occupied and operated as an unincorporated entity. It stands above all law and government except for God's. Here we are kings over our own soil, over our own comings and goings. While the land jurisdiction in commerce represents us as **the Primary Contractor, Preferential Creditor and Delegator** of all federal authority within and without the commercial jurisdictions of **The United States.**

The commercial Jurisdictions of **the Sea** and of **the Air** are both operating as incorporated entities, whose operations are in Commerce only. **Here is where the 2-party political system of D.C. is based.**

These two commercial vessels are tasked to do what sovereigns do not do by nature. Sovereignty stands 4 tiers above the foreign commercial jurisdictions and authorities. It stands over them as the Supreme authority. Sovereigns cannot step down to those positions without first laying down their sovereignty, which includes all birthrights, capacities, and inherited positions.

So, instead, we created governments, vessels, and positions, to handle international and global affairs for us in the realms of Commerce. Thus, the entire reason for the creation of our federal government(s).

**If you have eyes and ears to understand the above. Then you should be able to understand the bigger truths that lie in the public notice below.**

If this is the first time you have heard any of this? It may be quite shocking to your system, as truth can be. But nevertheless, don't cast it away, until you have given it your due diligence, and understood it well. It is counted as truth for the liberation of God's people in this nation.

## Differentiating specific names in our government

- **The United States of America** - is our country in geological terms.
- **The United States** - is the name of our Union, and
- **the states of America** is our unincorporated republic, that operates our international Land jurisdiction government.
- **(t)he UNITED STATES” INC.** - is the name of **the Foreign Federal Municipal subcontractor**, who operates the Global Air Government.
- **(t)he United States of America” (minor) or U.S.A. Inc.** - is the name of **the Foreign Federal Territorial subcontractor**, operating the International Sea/Maritime Government.

The latter two commercial jurisdictions hold limited delegated authority granted to them by **the Land Jurisdiction government of We the People**. **Yet today, these two foreign Commercial Subcontractors hold most all Americans bound in commercial captivity!**

**Sea & Air jurisdictions** have no inherent authority over **the land and soil jurisdiction**. Therefore, the **statutes of the federal subcontractors** do not lawfully bind **living men and women**. We are separated by jurisdictions, by the forms of law that govern each one separately, and their forms of law do not cross over into **the land jurisdiction**.

**Our organic Constitution - is a tri-lateral International Treaty & National Trust Indenture. It’s a Trilateral Contract between We the people and our federal Subcontractors.**

**“The United States” (the unincorporated Union)** is fully sovereign; it functions as a Holding Company for the unincorporated nation-states. To act as an instrument for the Sovereign people of the soil jurisdiction, to do business by trading their natural resources and goods in the realms of Commerce, by utilizing the instrumentality of **the International Land Jurisdiction, the International Maritime Sea Jurisdiction, and the Global Air Jurisdiction.**

“The Constitution is NOT an instrument for the Government to restrain the People; it is an instrument for the People to restrain the Government, lest it come to dominate our lives and interest.” -Patrick Henry

**Gen. 1:8 “the Law of Jurisdictions” and “those that hold dominion over them”.**

Law is the specific authority endowed over a certain bordered jurisdiction. In today’s system of Law, it is properly structured in the chart seen below.

**L = Land** (Standing upon the organic Constitution)

**A = Air** (Standing upon the Commercial Charter)

**W = Water /Sea** (Standing upon the Commercial Charter)

**Has God put our nation under foreign occupation or captivity under foreign authorities? Certainly not! At least not yet! But it could certainly happen if we don’t soon learn of our own national foundation and government frameworks.**

**Romans 13** does not apply to foreign subcontractors working in our country by treaties. It only applies to our lawful sovereign government and to Kingdom authorities placed over us **in our public trust**. Our nation, and indeed the very essence of Christendom within our borders stands at the proverbial crossroads with God today, while not being aware of the severity of our own situation, nor understanding the exponential remedy that We have “**right**” to bring forth.

Now, for our foreign subcontractors acting under false and fraudulent pretenses as officers and officials of the de jure government of “**The United States of America**” is a violation of the **Penal Code, if the “official” intends to induce another to submit to his pretended official authority** is also a violation of the victim's civil rights under Title 42 USC 1983.

Article VI of The organic Constitution, and the laws of **The United States “unincorporated”** which shall be made in pursuance thereof; and all treaties made, or which shall be made, **under the authority of The United States, shall be the Supreme Law of the Land**; and the judges in every state shall be bound thereby, anything in the Constitution or laws of any State to the contrary notwithstanding.

The above is the Sovereign Organic government by and for We the People.

This fundamental misunderstanding places every incorporated church, along with their members, into a form of **commercial captivity**, and **servitude**, making them unwittingly **SUBJECT to foreign laws, and those foreign principalities** that control those jurisdictions. Donald Trump is famous for pushing the envelope of Executive Power and for doing things that are audacious. If he is truly attempting to hand off **the Office of President of the United States inc.** to someone calling himself John Fitzgerald Lincoln Kahlooni Kennedy, it may be Trump's greatest attempted overreach yet. *(As crazy as that sounds there is real cause for alarm)* We say that "may" be because the paperwork we have received may be a hoax and is yet to be confirmed officially.

It has been suggested to us that we should appoint a president pro tem to assist us; fortunately, or unfortunately, our customs and traditions require open, free, and most importantly, public elections for **The President of The United States of America (Unincorporated)**.

It's not as far-fetched as it sounds to the layperson's ears.)*

There is no provision anywhere in any document or agreement, contract, treaty, or covenant for appointing a President -- not even the President **of a Subcontracting organization (which they are)**. **And we do Object!** *(Most Stringently)*

If Mr. Trump has attempted this appointment of Mr. Kennedy, it would echo moves we've seen before: Pope Benedict XVI handing off **the whole Babylonian System** to Pope Francis, **Pope Francis becoming "Patriarch of the West"**, **King Charles being coronated as Emperor Charles**, and similar aberrations as these men struggle to retain power and avoid accountability at the same time. If true, Trump's action would be a similar "Hail Mary" attempt to retain control

of an office he no longer has. (*The Corporation that he was President over, is now defunct by a settled bankruptcy in the World Court. So, therefore by law, He no longer has lawful standing or authority*)

The news that he doesn't have lawful standing to maintain the office, or, indeed, the assets of **the bankrupt UNITED STATES**, came as a great shock to him, and to the U.S. Military, and if Trump has actually put pen to paper on this matter, and in effect tried to appoint **a new President**, that would indicate that they still don't grasp the meaning of that circumstance, and the history that has been placed squarely in front of their faces.

*(They no longer hold lawful authority in this nation from any presumed position, no matter if you want them too or not.) (By Law he doesn't, and all the assets from that Bankruptcy come back to We the people, at a state's assembly level. Including all the offices that come with that bankrupt entity. Restoring 2/3rds of our nation's power and authority back into the hands of We the people. That is the law. That is what happened, opinions aside. Now, what do we do?)*

The U.S. Military itself is still not redeemed, even though they have a contract to provide services under **The Constitution "of" the United States of America**. They are still functioning as a **Mercenary Force**, and they have not been returned to **their honorable and lawful standing**. **They are still working for the British Crown**, and only indirectly for **the American Government**.

We doubt that the men and women working as part of, or in support of, the U.S. Military have been given this information. That they are working as mercenaries, first and foremost will be a shock; that they are working as **British Territorial Mercenaries** and only secondarily for "America" ...will be an even greater shock.

We have undertaken our proper role as the Receiver and Priority Creditor of the assets of **the UNITED STATES corporation, which includes "all the Offices of "this bankrupted**

**organization. That includes the Office of the President of the United States Incorporated.**

So once again, (if the claim above is true, it would appear that) **the British** are trying to "sell what isn't theirs" and assume an ownership interest that they never had, and exercise coercive power over property that isn't theirs, was never theirs, and has nothing to do with them, to put it bluntly. (It's warfare & witchcraft on a national and international level)

Over the years since the so-called American Civil War, the remaining **two foreign Federal Service Providers**, have colluded so that one man occupying a **corporate office "as if" it was our Public Office**, was in control of **the UNITED STATES, INC.** as "President", and in control of **the U.S.A. Using the smokescreen of the "Civil War," these two colluding government subcontractors did everything they could, to obscure the existence of **the actual American Government**, and took every measure to suppress and remove **those officers of the American Government** who knew the truth.

***It's Grammer fraud through Semantic deception, and its purposeful Witchcraft!***

***(Therefore Churches, if you identify with them, by utilizing their corporate constructs, by obeying and following their forms of foreign law, over and above the sovereign form of law you hold in your own country, and if you choose their form of citizenship, over your sovereign birthright, then you are one of them by your practice and by your belief. It means you have laid down your birthright authority for mere corporate privileges. Even if you are completely unaware of these facts.) Thus, the danger all our churches are in, through their own ignorance.)***

Right now, **the Brits** are trying desperately to retain their advantage. They quite rightly perceive that our misguided "military" is the only thing standing between them and the inevitable day, when they are held accountable by our countrymen, and the rest of the world. *(But the big question is, how far must we fall before our Churches, and the rest of the world begins to see the real peril that we're truly in?) **States Assemblies are now holding both **the Brits**, and Donald Trump Accountable.** They never stood as America first. This Change enabled them to manipulate the decisions of government, and abuse the powers of government, to get their own way and serve their own self-interest, the commercial corporations have engaged in crimes on a massively large scale: war for profit, enslavement and

Any and all corporate officers of the UNITED STATES or any successor organization(s) inheriting "federal" or "State" service contracts who support, condone, or promote crimes against the American States or against American State Citizens shall be subject to arrest and prosecution for commercial and violent crimes.

All foreign officials operating as elected or appointed officials of (t)he United States of America (minor) who support, condone, or promote such crimes against the American States or against American State Citizens shall be subject to arrest, confiscation of their assets, and deportation to Puerto Rico, Guam, or such other "states" as may be willing to receive them.

Insomuch as corporate officers operating (t)he United States of America, (incorporated) and the UNITED STATES INC. have contrived under conditions of fraud and semantic deceit to re-venue the estates of the American States and living American State Citizens to the foreign jurisdiction of (t)he United States of America (minor) they are found guilty of capital crimes, including acts of fraud and treason committed between 1933 and 1945, and are condemned posthumously. **The British Parliament and British Monarch**, by whatever hidden process they operate, need to come to the same conclusion the Pope came to.

They are in receipt of "goods" stolen not only from the British people, but from Americans and people of the former Commonwealth, seventeen Western European nations, Japan, the Philippines, Libya, Iraq, Syria, and most of Africa, except those countries similarly plundered by FRANCE, INC..... and the list goes on.

Bouvier’s Law Dictionary was written before the B.A.R. Associations came to control everything in America, by the very actions of the Black’s Law Dictionaries.

Bouvier’s was written when the Constitution, the common law, and the maxims of law, were still the highest authority in all courtrooms.

This was the era when the people stood as the lawful sovereign birthright heirs of the nation, when the courts were required to obey natural law, public law, common law and constitutional limitations.

Blacks law dictionary came later, after the rise of the BAR Association. Over time, each new Black's Law Dictionary edition slowly removed more of the maxims and softened their meanings, and replaced natural law, with statutory interpretations, and administrative procedure.

This shifted Sovereign Power away from the people, which caused every new meaning of every changed word to lean towards the Corporations, Bankers, Judges, Politicians and the government agencies they created.

In Black's law dictionary, this maxim becomes the suggestion, it applies unless the court decides it does not, it applies unless the party fails to object, it applies unless the judge finds no prejudice. This removes the safeguard and replaces it with judicial discretion.

3.) A thing that is void, is as though it never existed. Bouvier treats void actions as a legal nullity. Black's law changes void into two categories void and voidable. Blacks allows a void action to still produce consequences, if the court decides to enforce it.

This defeats the entire purpose of the maxim. You can see the pattern clearly.

## Historical Timeline and Summary

- **Yeshua** appears during this period. He comes to the House of Judah first. States His mission for "**the lost sheep of Israel**" (Matt. 15:24).

- Apostle Paul brings the gospel of Yeshua to the Gentiles, extending His redemption to them as well.

### Post-Biblical Era (70 AD to Present)

**Ezekiel 37:21–22 One King over the regathered Israel - “Behold, I will take the children of Israel from among the heathen... and will gather them on every side... and I will make them one nation... and neither will they be divided into two kingdoms any more... **And One King shall be king to them all.**”**

Paul, speaking to the believers in Galatia, you have run well, *and learned much spiritually*. So, who has bewitched you? Who has hindered you from obeying the truth? This persuasion comes not from Him who called you. Paul reiterates, if you are not obeying the truth, you are foolish.

It is not an obvious thing today, that American Christians are bewitched, made unwittingly foolish, and altogether misled from the truth of our real-world condition. But unless there is a movement back to the fullness of God’s Word, to His Covenant Agreement, and to our own national covenants, then the bewitching will not stop, and our disobedience to truth will only continue.

The body of this letter has shown you the modern bewitchment and those who beguiled us.

Now, stand fast therefore in the liberty wherewith Christ hath made us free and be not entangled again with the yoke of bondage. (Set yourself to mature within your birthright inheritance. Gal. 4)

When The House of God in America comes into the fullness of Her Identity; National Repentance, National Restoration, National Realignment, National Restructuring and a National Unified Body will be the Order of the Day. However, that may look.

When Our Lawful Identity is Restored, So Then Is Our Authority!
