The recommendation is based on this performance evaluation plus reference to salary surveys conducted by United Way Worldwide for chief professional officers of comparably sized and situated United Ways, with further reference to compensation levels of other nonprofit organization in our geographic area. The final decision on compensation is made by the Executive Committee.
