I hereby authorize the required repair work to be completed on my vehicle along with the necessary materials. I hereby grant Barron's Body Shop and its employee permission to operate the vehicle here in described on street, highway, or elsewhere for the purpose of testing and inspection.

I understand that Barron's Body Shop final invoice for repairs of my vehicle may not match that of the insurance company's estimate as to parts, labor or procedures used to repair my vehicle. I understand that of the insurance company's estimate as to parts, lab or procedures used to repair my vehicle. I understand that I may be responsible for additional costs of required procedures or parts not covered by an insurance company. I understand that repair techniques used are based upon Barron's Body Shop professional experience as to the best means of effecting a high-quality repair and based on approved or recommended OEM procedures, and that Barron's Body Shop labor charges are based upon hourly time allowances as given in the Collision repair industry estimating software, and their experience, and may be more or less than the amount of actual time.

I understand that all **Barron's Body Shop** estimates and final invoices are based upon flat rate hours as is customary in the Collision Repair industry, not actual time spent on repairs. I understand that a flat rate hour is a unit of time given for a certain repair operation and that actual time spent on a repair operation can vary greatly from the flat rate time given to a labor procedure depending on technician experience and equipment provided and/or training.

Barron's Body Shop is not responsible for loss or damage to vehicles and/or articles left in vehicles in case of fire, theft, or any cause beyond our control. Please remove any personal articles from your vehicle as it may be necessary to have outside companies do sublet work on your vehicle.

An express mechanic's lien is hereby acknowledged on the above vehicle should the need occur, to secure the amount of remaining balance due. No vehicle will be released until payment is made in full.

Please be certain all payees (including all lien holders) have endorsed the insurance check prior to completion of repairs.

Storage charges will accrue 5 days after notification of the completion of repairs. Failure to make payment within 20 days of notification of the completion of repairs will result in the commencement of the auction process to satisfy the implied mechanic's lien.

In the event that an insurance company fails to provide an estimate or there is an inability to come to an agreed price for the cost of either the initial estimate or supplement within 10 business days of the vehicle arriving at **Barron's Body Shop**, there will be a storage charge of \$60.00 per day beginning with the day the vehicle arrived at Barron's Body Shop.

Vehicles towed or driven in, then deemed a total loss, or moved to another facility for any reason by the Customer or Insurance Company may be subject to administrative, lot debris cleanup charges, estimate fees, and/or any storage fees. Any labor, towing, or lift inspection fees must be paid before a vehicle leaves Barron's Body Shop. Prior written notice must be given if return of used or damaged parts is desired by the customer.

Methods of payment

- All checks must be accompanied by a driver's license.
- Personal or Business checks must have driver's license information (license must be presented), signature on shop invoice, contact phone numbers.
- Cashier's check, money order, properly endorsed Insurance checks and cash.
