Founders of Tile Heritage Foundation To Be Honored

Taylor and Menzies Named 2003 Cesery Award Winners

TCAA will add two more luminaries to a constellation of tile industry leaders when it presents the 2003 Cesery Award to Joseph A. Taylor and Sheila A. Menzies of the Tile Heritage Foundation. Joe and Sheila will receive their awards during the Cesery Award Luncheon on October 21 at TCAA's 100th Anniversary Convention in Savannah, Georgia.

According to John J. Sekora, who submitted their nomination, "It is most fitting that in its centennial year, TCAA honors two individuals who have dedicated themselves wholeheartedly to preserving the history and culture of our great industry. I can't think of anyone more deserving than Joe and Sheila to join the exalted ranks of Cesery Award recipients."

Joe and Sheila co-founded Tile Heritage Foundation in 1987. Joe, a writer and educator, serves as current president of the Foundation and editor of its publications. A frequent writer and lecturer on tile history, Joe has focused much of his research on the evolution of tile manufacturing in California. Joe has been a principal contributor to numerous publications, including *California Tile: The Golden Era 1910-1940*, which will be published by Schiffer this year. He began his love affair with ceramic tile in the 1970's when he worked at McIntyre Tile Company in Healdsburg, California.

Sheila serves as the Foundation's treasurer, the primary designer of THF publications and coordinator of its educational events. She is a craftswoman and mixed media artist with a background in stage-set design and theater costume design. Sheila has traveled extensively in the United States, Great Britain, Portugal and Italy documenting historic and contemporary tile installations.

The passion of Joe Taylor and Sheila Menzies is best expressed in Sheila's own words. "I want to preserve tile, view it and live with it. I want to encourage tile's continued usefulness as well as promote its beauty. I want to see ceramic surfaces respected as the legitimate art form they are, a collage of personal and group statements in color and form which shape and blend with our lives." Plan to join us in Savannah as we honor Joe and Sheila for their dedication and accomplishments.



PROFILES OF THE PAST

EXCERPTS FROM TCAA's ANNIVERSARY BOOK "Ceramic Tile in 20th Century America"

Charles P. Brecher – TCAA's 1st President

He was known as one of TCAA's founding fathers – the captain of the 'Old Guard.' Charles P. Brecher was our association's first president. It was under his leadership that the foundations and traditions of what would become one of America's oldest and basic entities were set.

Our first annual convention was held in St. Louis, Missouri, in July of 1904. Charles P. Brecher of Louisville was elected as the first president of what would then be known as the Interstate Mantel and Tile Dealers' Association (IMTDA) – a newly formed tile guild. Nearly 100 years later this trade organization would be known as the Tile Contractors' Association of America (TCAA).

Ben P. Phillips of Nashville was elected as our first secretary, and W. J. Northcross as treasurer.

Just two years earlier, in 1902, Brecher had organized his own mantel and tile company known as the Brecher-Buck Company of Louisville, Kentucky. He would also eventually form another tile dealership - the Burdorf-Brecher Co.

Mr. Brecher maintained an active membership in our association up to and throughout the 1920s. At age 89, he still served as chairman of the board of another of his many entities - the Brecher Company, a lighting-equipment firm, and the Columbia Manufacturing Company, a table-making firm, both in Louisville. He remained active in the business community up until his death on January 11, 1962.

Although much of the early history of both Charles P. Brecher and the organization he lead has been lost, there is evidence that the association grew rapidly. By the time the 8th Annual Convention was held in 1911, the Hotel Astor in New York City was needed to accommodate the large numbers of members in attendance.
