# Tile Contractors' Association of America Scholarship Program Eligibility and Instructions

## **Employee Eligibility Criteria**

- Must be a current full-time employee, and considered as overhead staff, of a TCAA contractor member company meeting the standards for good standing with the Association.
- TMT union employees are not eligible.

### **Applicant Eligibility Criteria**

- Applicants must be employee's siblings, children, or grandchildren only, and if requested, must provide proof of eligibility by blood, marriage, or legal dependency.
- A letter from the TCAA administrators will be provided to verify the status of the contractor member.
- Scholarships based solely on merit and judged based on previous year's grade point average.
  GPA, SAT, ACT, etc.
- Available to high school seniors and/or full-time matriculated college or university students at any accredited two or four-year school. Vocational or technical schools are not eligible.
- Previous winners are not eligible; however, previous applicants are eligible.

#### **APPLICATION INSTRUCTIONS**

- A letter from the owner of the TCAA member firm must be submitted with each application, on their company letterhead, verifying the employee eligibility criteria listed above.
- Provide a listing of all honors or awards received for academic excellence.
- Include two teacher recommendation letters.
- Provide official transcripts.
- ❖ Completed application, along with supporting documents, here by APRIL 7, 2024.

**Selection:** TCAA has sole authority for granting the scholarship awards. TCAA members serving on the Scholarship Committee select the winners. All decisions are final. Applications and attachments become the property of TCAA.

Award: One Family Scholarship will be awarded in the amount of \$5,000

Successful recipient will be notified by July 2024
