2022 SPONSORSHIP AGREEMENT

Terms & Conditions

1. This Agreement shall be binding upon signature.
2. The Sponsor hereby submits the signed Agreement for Sponsorship at the 2022 International Meeting for Applied Geoscience & Energy (IMAGE) of the American Association of Petroleum Geologists (AAPG) and Society of Exploration Geophysicists (SEG) to be held 28 August – 2 September 2022 at the George R. Brown Convention Center, Houston, Texas.
3. Sponsorships are non-refundable and non-transferable. In the event IMAGE cancels a sponsored item, the current sponsors will be contacted with an opportunity to move the contribution to another item/event.
4. All Sponsorship amounts are listed in U.S. dollars and must be paid in U.S. dollars.
5. Sponsorship fulfillment cannot be guaranteed unless Sponsorship is fully paid. Payment is due upon receipt of invoice.
6. Sponsors who are also exhibitors will receive an 8½" x 11" sign denoting sponsorship to display inside booth.
7. Sponsor hereby grants IMAGE a non-exclusive license to use Sponsor Brand only in connection with advertising and promotion of the IMAGE. Any use of the Sponsor Brand shall be carried out pursuant to the instructions of Sponsor and IMAGE shall be fully responsible for the fulfillment of these provisions. At the end of IMAGE, IMAGE must return or destroy, as appropriate, the materials including Sponsor Brand, as well as refrain from using them, unless authorized by Sponsor. None of the statements set forth in this Agreement constitutes the assignment or transfer of any intellectual or industrial property rights held by Sponsor.
8. Exclusive sponsorships will be given priority over co-sponsorships.
9. Some items/events may not be available if the full amount of sponsor dollars requested is not reached. In this case, the current sponsors committed will be contacted with an opportunity to move contribution to another item/event.
10. All advertising materials and copy must be submitted and approved by IMAGE Show Management in advance. Your sales rep will reach out with date the materials are due and submission instructions.
11. Sponsor shall defend, indemnify, and hold AAPG/SEG harmless from all liability, costs, and damages relating to acts and omissions of Sponsor and its employee's, agents, and contractors associated with the Event.
12. If for any reason the Event is not held, IMAGE may terminate this Agreement prior to the Event start date.
13. This Agreement contains the complete agreement of the parties, and all prior agreements, whether verbal or written will be null and void. This Agreement shall be governed by and construed and enforced in accordance with the laws of the State of Oklahoma, USA (without regard to any conflict of laws principles). All actions arising out of or in connection with this Agreement shall be brought in the Oklahoma District Court, Tulsa County, Oklahoma, USA which shall be the exclusive forum therefor. The parties here to hereby irrevocably submit to the personam jurisdiction and process of the Oklahoma District Court, Tulsa County, Oklahoma, United States of America, and agree that service by certified mail to their addresses shall constitute sufficient service of process.
