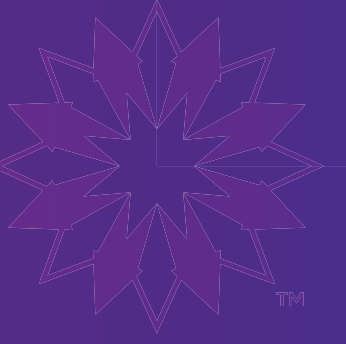

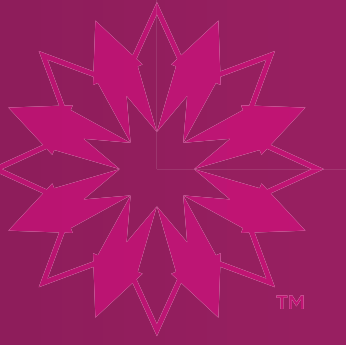

THE LOGO SIGNATURE

The word logo is really a slang term for the more formal and legal term trademark. In most cases, a logo or trademark is composed of two distinct elements: the symbol, which is the graphic element, and the wordmark, which is the lettered word (“logos” is Greek for “word”). When those elements are combined into one graphic, they are referred to as a signature.

Formed by the symbol and wordmark, the signature is the primary visual representation of the Stellar MLS brand.

Signature elements must always appear **crisp, clear and readable**. The colors must be consistent regardless of the medium, substrate or reproduction process. To ensure uniformity, use only the approved artwork.

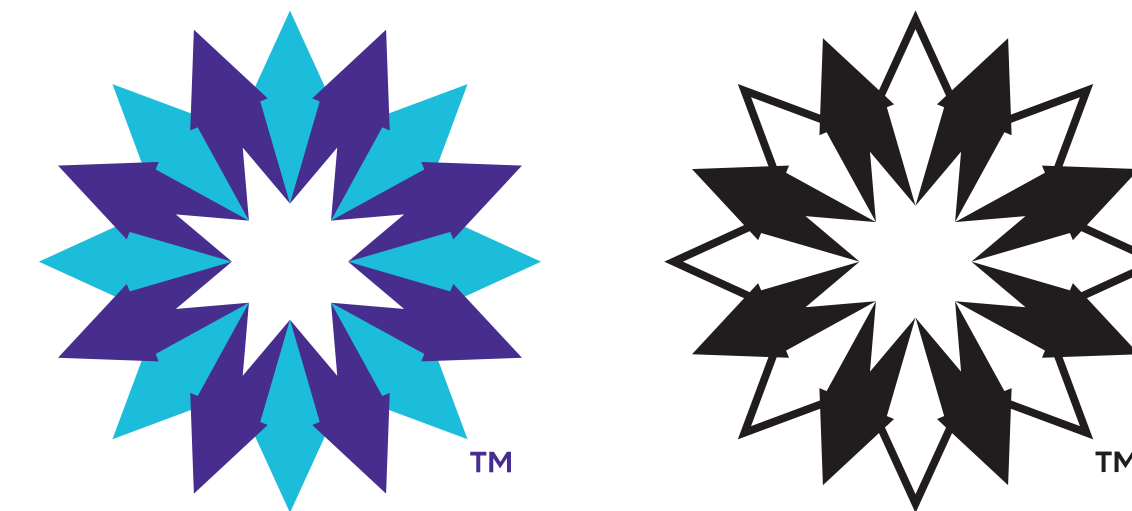


THE SYMBOL

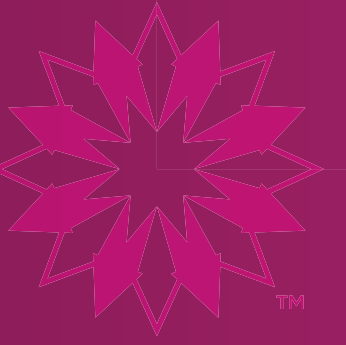
When the full signature cannot be used because of size or design constraints, use the Stellar MLS symbol without the logotype.

Please don’t use the symbol as a replacement for the signature—use it for social media, favicons, interface design or other applications that require a small representation of our brand or where available space is a challenge. **The symbol should never be used without additional context that identifies the communication as authored by Stellar MLS.**

The symbol may be used as a background design element, but never use the symbol as an icon or bullet, which would dilute the symbol’s strength as the primary representation of the brand.

SIGNATURE VERSIONS

So that the brand looks great in any application, we have horizontal and vertical versions for both print and on-screen use.



SINGLE-COLOR LOGO

Use the full black or white logo only when only one color option is available, such as for single-color printing, or engraving on promo items.



REVERSE LOGOS

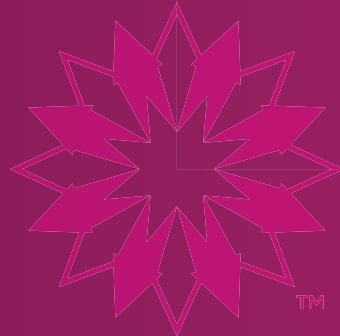
The Stellar MLS logo suite includes reverse signature versions for reproduction on a dark or photographic background that would otherwise render the color version of the signature unreadable. Depending upon application, CMYK, RGB, PMS coated and PMS uncoated versions are available.



GRAYSCALE LOGO

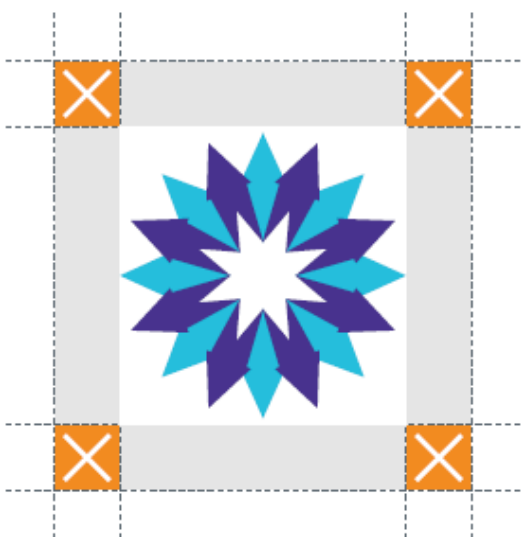
The Stellar MLS logo suite includes a grayscale version. Use the grayscale version for print applications where budget restrictions require 1-color printing, or for low-end reproduction methods, such as photocopies or facsimiles.





SPACE AROUND LOGO

A clear space equal to approximately 1/2 the height of the lower-case letters in the wordmark (indicated by the "X" in the depiction) must always be maintained around the signature and symbol. No other elements should appear within this space.



RESTRICTIONS

The StellarMLS signature has been carefully designed to work well in any design environment and across media. Do not modify the signature in any way, and use only the approved artwork. Here are some examples of signature modifications that are not allowed, and do not support our brand.

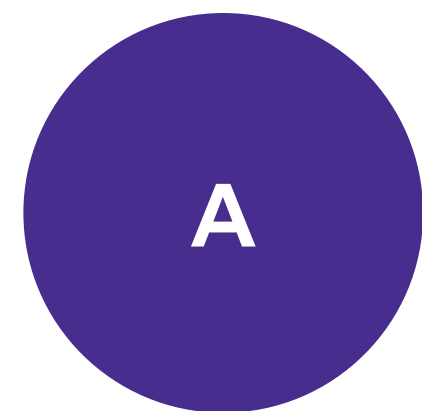
